House Bill (HB) 4197, as Filed by Representative Debbie Riddle - Relating to the powers and duties of the Pine Forest Municipal Utility District; providing authority to issue bonds and impose a tax

Dear Speaker Straus:

The following comments are provided pursuant to the Constitutional requirements referenced above. Under those requirements, the TCEQ must submit, to the Governor, Lieutenant Governor and Speaker of the House of Representatives, the TCEQ's recommendations on specific legislation affecting water districts. We recommend that these comments be considered in the evaluation of the proposed legislation.

The bill amends previous legislation related to the Pine Forest Municipal Utility District of Harris County (the "District") to clarify that the District operates under and has the powers and duties provided for in Water Code Chapters 49 and 54, and to grant the District road powers. The District retains all rights, powers, privileges, authority, duties, and functions that it had before the effective date of the bill.
