- 3 <u>2016-2017</u>" and substitute "<u>2015-2016</u>, <u>2016-2017</u>, and <u>2017-2018</u>".
- 4 (2) On page 11, line 15, strike "August 31, 2017" and
- 5 substitute "August 31, 2018".
- 6 (3) On page 11, line 16, strike "September 1, 2017" and
- 7 substitute "September 1, 2018".
- 8 (4) On page 11, line 20, strike "2017-2018" and substitute
- 9 "2018-2019".
- 10 (5) Add the following appropriately numbered SECTION to the
- 11 bill and renumber subsequent SECTIONS of the bill accordingly:
- 12 SECTION ____. Notwithstanding Chapter 4 (S.B. 1), Acts of
- 13 the 82nd Legislature, 1st Called Session, 2011, and regardless of
- 14 whether the constitutional amendment proposed by S.J.R. 1, 84th
- 15 Legislature, Regular Session, 2015, is approved by the voters, the
- 16 following provisions are effective September 1, 2018:
- 17 (1) Section 57.03, Chapter 4 (S.B. 1), Acts of the
- 18 82nd Legislature, 1st Called Session, 2011, which amended Section
- 19 12.106(a), Education Code;
- 20 (2) Section 57.18, Chapter 4 (S.B. 1), Acts of the

- 22 heading to Section 42.2516, Education Code;
- 23 (3) Section 57.19, Chapter 4 (S.B. 1), Acts of the
- 24 82nd Legislature, 1st Called Session, 2011, which amended Section
- 25 42.2516(a), Education Code;
- 26 (4) Section 57.23, Chapter 4 (S.B. 1), Acts of the
- 27 82nd Legislature, 1st Called Session, 2011, which amended Section
- 28 42.253(h), Education Code;
- 29 (5) Section 57.29, Chapter 4 (S.B. 1), Acts of the

- 1 82nd Legislature, 1st Called Session, 2011, which amended Section
- 2 26.08(i), Tax Code;
- 3 (6) Section 57.32(a), Chapter 4 (S.B. 1), Acts of the
- 4 82nd Legislature, 1st Called Session, 2011, which repealed various
- 5 provisions of the Education Code; and
- 6 (7) Section 57.32(b), Chapter 4 (S.B. 1), Acts of the
- 7 82nd Legislature, 1st Called Session, 2011, which repealed Sections
