FLOOR AMENDMENT NO.____

- Amend C.S.S.B. No. 1 (house committee report) as follows:
- 2 (1) On page 10, lines 16 and 17, strike "2015-2016 and
- 3 <u>2016-2017</u>" and substitute "<u>2015-2016, 2016-2017, 2017-2018, and</u>
- 4 2018-2019".
- 5 (2) On page 11, line 15, strike "August 31, 2017" and
- 6 substitute "August 31, 2019".
- 7 (3) On page 11, line 16, strike "September 1, 2017" and
- 8 substitute "September 1, 2019".
- 9 (4) On page 11, line 20, strike "2017-2018" and substitute
- 10 "2019-2020".
- 11 (5) Add the following appropriately numbered SECTION to the
- 12 bill and renumber subsequent SECTIONS of the bill accordingly:
- SECTION ____. Notwithstanding Chapter 4 (S.B. 1), Acts of
- 14 the 82nd Legislature, 1st Called Session, 2011, and regardless of
- 15 whether the constitutional amendment proposed by S.J.R. 1, 84th
- 16 Legislature, Regular Session, 2015, is approved by the voters, the
- 17 following provisions are effective September 1, 2019:

- 20 12.106(a), Education Code;

- 27 (4) Section 57.23, Chapter 4 (S.B. 1), Acts of the
- 28 82nd Legislature, 1st Called Session, 2011, which amended Section
- 29 42.253(h), Education Code;

- 1 (5) Section 57.29, Chapter 4 (S.B. 1), Acts of the
- 2 82nd Legislature, 1st Called Session, 2011, which amended Section
