- Amend S.B. No. 200 (house committee printing) as follows:
- 2 (1) Add the following appropriately numbered SECTIONS to
- 3 ARTICLE 3 of the bill and renumber subsequent SECTIONS of that
- 4 ARTICLE accordingly:
- 5 SECTION 3.\_\_\_. Section 98.1046(a), Health and Safety Code,
- 6 is amended to read as follows:
- 7 (a) The [In consultation with the Texas Institute of Health
- 8 Care Quality and Efficiency under Chapter 1002, the] department,
- 9 using data submitted under Chapter 108, shall publicly report for
- 10 hospitals in this state risk-adjusted outcome rates for those
- 11 potentially preventable complications and potentially preventable
- 12 readmissions that the department[, in consultation with the
- 13 institute, has determined to be the most effective measures of
- 14 quality and efficiency.
- SECTION 3.\_\_\_\_. Section 98.1047(a), Health and Safety Code,
- 16 is amended to read as follows:
- 17 (a) The [In-consultation with the Texas Institute of Health
- 18 Care Quality and Efficiency under Chapter 1002, the] department
- 19 shall study which adverse health conditions commonly occur in
- 20 long-term care facilities and, of those health conditions, which
- 21 are potentially preventable.
- 22 SECTION 3.\_\_\_\_. Section 98.1065, Health and Safety Code, is
- 23 amended to read as follows:
- 24 Sec. 98.1065. STUDY OF INCENTIVES AND RECOGNITION FOR
- 25 HEALTH CARE QUALITY. The department[ , in consultation with the
- 26 Texas Institute of Health Care Quality and Efficiency under Chapter
- $27 \frac{1002_7}{2}$ ] shall conduct a study on developing a recognition program to
- 28 recognize exemplary health care facilities for superior quality of
- 29 health care and make recommendations based on that study.

- 1 (2) Strike page 130, line 9 through page 131, line 13 and
- 2 renumber subsequent SECTIONS of that ARTICLE accordingly.
- 3 (3) Strike page 134, line 20 through page 135, line 2 and
- 4 substitute the following:
- 5 (7) Chapter 115; and
- 6 (8) Chapter 1002.
- 7 (4) On page 135, between lines 5 and 6, insert the
- 8 following:
- 9 (d) Section 848.001(7), Insurance Code, is repealed.
- 10 (5) On page 136, line 14, strike "the board of directors 11 of".
