1 Amend S.B. No. 200 (house committee report) by adding the
2 following appropriately numbered SECTION to ARTICLE 2 of the bill
3 and renumbering subsequent SECTIONS of ARTICLE 2 accordingly:

4 SECTION 2.____. (a) Subchapter B, Chapter 531, Government
5 Code, is amended by adding Section 531.0911 to read as follows:

6 Sec. 531.0911. PHOTOGRAPH AND OTHER INFORMATION ON CERTAIN
7 ELECTRONIC BENEFITS TRANSFER CARDS. (a) In this section:

8 (1) "Financial assistance program" means the
9 financial assistance program established under Chapter 31, Human
10 Resources Code.

11 (2) "Recipient" means a person who receives benefits
12 under the financial assistance program or the supplemental
13 nutrition assistance program.

14 (3) "Supplemental nutrition assistance program" has
15 the meaning assigned by Section 33.0005, Human Resources Code.

16 (b) Subject to Subsection (c), the commission shall ensure
17 that the front side of each electronic benefits transfer card used
18 by a recipient, or other person authorized on the recipient's
19 account, for purposes of receiving benefits under the financial
20 assistance program or the supplemental nutrition assistance
21 program displays:

22 (1) the name and photograph of the recipient or other
23 authorized person, as appropriate;

24 (2) the words "Fraud Hotline" followed by the
25 telephone number of the commission's toll-free hotline for
26 reporting suspected fraud required under Section 531.108(b)(2);

27 (3) the Internet website address maintained by the
28 commission for the purpose of allowing persons to report suspected
29 fraud in either the financial assistance program or the

1 supplemental nutrition assistance program; and

2 (4) the statement "Funds provided by taxpayers."

3 (c) A recipient, or other person authorized on the
4 recipient's account, as appropriate, is exempt from the photograph
5 requirement imposed by Subsection (b) if the person is:

6 (1) 65 years of age or older;

7 (2) younger than 19 years of age;

8 (3) blind;

9 (4) disabled; or

10 (5) a victim of domestic violence.

11 (d) The executive commissioner may adopt rules necessary to
12 implement Subsection (c).

13 (b) Notwithstanding Section 531.0911, Government Code, as
14 added by this section, the Health and Human Services Commission is
15 not required to issue electronic benefits transfer cards that
16 comply with that section until September 1, 2016, but is required to
17 begin issuing cards that comply with that section beginning on that
18 date. The commission shall ensure that on or before August 31, 2018,
19 each electronic benefits transfer card used to deliver benefits to
20 recipients under the financial assistance program under Chapter 31,
21 Human Resources Code, or the supplemental nutrition assistance
22 program under Chapter 33, Human Resources Code, conforms to Section
23 531.0911, Government Code, as added by this section.
