A BILL TO BE ENTITLED

AN ACT relating to certain criminal and civil consequences of trafficking of persons, compelling prostitution, and certain other related criminal offenses; to the prevention, prosecution, and punishment of those offenses, and to compensation paid to victims of those offenses.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

(b) A party to an offense under this chapter may not be 3 prosecuted for any offense about which the party is required to 4 provide evidence or testify, and the evidence and testimony may not 5 be used against the party in any adjudicatory proceeding except a 6 prosecution for aggravated perjury. For purposes of this 7 subsection, "adjudicatory proceeding" means a proceeding before a 8 court or any other agency of government in which the legal rights, 9 powers, duties, or privileges of specified parties are determined. 10

11 (c) A conviction under this chapter may be had on the 12 uncorroborated testimony of a party to the offense.

13 SECTION 14. Section 43.02(c), Penal Code, is amended to 14 read as follows:

15 (c) An offense under this section is a Class B misdemeanor,16 except that the offense is:

17 (1) a Class A misdemeanor if the actor has previously
18 been convicted one or two times of an offense under this section;

(2) a state jail felony if the actor has previously
been convicted three or more times of an offense under this section;
or

(3) a felony of the second degree if the person
23 solicited is:

24 <u>(A)</u> younger than 18 years of age, regardless of 25 whether the actor knows the age of the person solicited at the time 26 the actor commits the offense<u>;</u>

(B) represented to the actor as being younger

1 than 18 years of age; or

2 (C) believed by the actor to be younger than 18

3 years of age.

4 SECTION 15. The change in law made by this Act to Article 5 12.01, Code of Criminal Procedure, does not apply to an offense if 6 the prosecution of that offense becomes barred by limitation before 7 the effective date of this Act. The prosecution of that offense 8 remains barred as if this Act had not taken effect.

9 SECTION 16. The changes in law made by this Act to Chapter 10 56, Code of Criminal Procedure, apply only to a criminal offense committed or a violation that occurs on or after the effective date 11 of this Act. A criminal offense committed or a violation that 12 occurs before the effective date of this Act is governed by the law 13 14 in effect on the date the offense was committed or the violation 15 occurred, and the former law is continued in effect for that purpose. For purposes of this section, a criminal offense was 16 committed or a violation occurred before the effective date of this 17 Act if any element of the offense or violation occurred before that 18 date. 19

SECTION 17. The changes in law made by this Act to Article 20 62.001(5), Code of Criminal Procedure, and Sections 20A.03 and 21 43.02, Penal Code, apply only to an offense committed on or after 22 the effective date of this Act. An offense committed before the 23 24 effective date of this Act is governed by the law in effect on the date the offense was committed, and the former law is continued in 25 26 effect for that purpose. For purposes of this section, an offense was committed before the effective date of this Act if any element 27

1 of the offense occurred before that date.

2 SECTION 18. (a) Not later than December 1, 2015, the 3 Supreme Court of Texas shall adopt the rules necessary to provide 4 the training required under Section 22.011, Government Code, as 5 amended by this Act.

6 (b) Not later than December 1, 2015, the Texas Court of 7 Criminal Appeals shall adopt the rules necessary to provide the 8 training required under Section 22.110, Government Code, as amended 9 by this Act.

10 (c) Notwithstanding Section 22.110, Government Code, as 11 amended by this Act, a judge, master, referee, and magistrate who is 12 in office on the effective date of this Act must complete the 13 training required by Section 22.110, Government Code, as amended by 14 this Act, as applicable, not later than December 1, 2017.

15 SECTION 19. The change in law made by this Act in adding 16 Section 20A.04, Penal Code, applies to a criminal proceeding that 17 commences on or after the effective date of this Act. A criminal 18 proceeding that commences before the effective date of this Act is 19 covered by the law in effect when the proceeding commenced, and the 20 former law is continued in effect for that purpose.

SECTION 20. This Act takes effect September 1, 2015.
