8	Sec. 53.001. DEFINITIONS. In this chapter:
9	(1) "Department" means the Department of Family and

- Sec. 53.002. VETERANS AND MILITARY FAMILIES PREVENTIVE 18
- SERVICES PROGRAM. (a) The department shall develop and implement a 19
- preventive services program to serve veterans and military families 20
- 21 who have committed or experienced or who are at a high risk of:
- 22 (1) family violence; or
- 23 (2) abuse or neglect.

1	(1) be designed to coordinate with community-based

- 5 volunteer coordinator certification training to volunteer

- 7 certification and recertification and providing continuing
- 8 education.
- 9 (b) The commission shall manage and coordinate the peer
- 10 training program to include initial training, advanced training,
- 11 certification, and continuing education for peers associated with
- 12 the mental health program for veterans.
- SUBCHAPTER I. COMMUNITY COLLABORATION INITIATIVE
- 14 Sec. 434.401. COMMUNITY COLLABORATION. (a) The commission
- 15 and the Department of State Health Services shall include as a part
- 16 of the mental health program for veterans described by Section
- 17 434.352(a) an initiative to encourage local communities to conduct
- 18 cross-sector collaboration to synchronize locally accessible
- 19 resources available for veterans and military service members.
- 20 (b) The initiative must be designed to encourage local
- 21 communities to form a committee that is tasked with developing a
- 22 plan to identify and support the needs of veterans and military
- 23 service members residing in their community. The commission may
- 24 designate general areas of focus for the initiative.
- 25 SECTION 3. This Act takes effect immediately if it receives
- 26 a vote of two-thirds of all the members elected to each house, as
- 27 provided by Section 39, Article III, Texas Constitution. If this
