9 <u>(d) A person commits an offense if the person discloses</u> 10 <u>confidential information obtained under this section. An offense</u> 11 <u>under this subsection is a Class C misdemeanor.</u>

SECTION 7. Section 571.176(a), Government Code, is amended to read as follows:

14 (a) The commission may impose a civil penalty of not more
