4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:									
5	SECTION 1. Subchapter A, Chapter 12, Election Code, is									
6	amended by adding Section 12.007 to read as follows:									
7	Sec. 12.007. CERTAIN ELECTION OFFICERS ARE VOTER									
8	REGISTRARS. An election officer serving a polling place for early									
9	voting by personal appearance is a deputy voter registrar and has									
10	the same authority as a regular deputy registrar.									
11	SECTION 2. Section 65.051(a), Election Code, is amended to									
12	read as follows:									
13	(a) The early voting ballot board shall verify and count									
14	provisional ballots as provided by this subchapter not later than									
15	the <u>10th</u> [seventh] day after the date of an election.									
16	SECTION 3. Section 65.054, Election Code, is amended by									
17	amending Subsection (b) and adding Subsection (b-1) to read as									
18	follows:									
19	(b) Except as provided by Subsection (b-1), a $[A]$									
20	provisional ballot may be accepted only if the board determines									
21	that, from the information in the affidavit or contained in public									
22	records, the person is eligible to vote in the election and has not									
23	previously voted in that election.									
24	(b-1) A provisional ballot cast under Section 85.0312 shall

1 <u>be accepted if the voter registrar determines the applicant is</u> 2 <u>eligible for registration under Section 85.0312(d).</u>

3 SECTION 4. Section 67.003, Election Code, is amended to 4 read as follows:

5 Sec. 67.003. TIME FOR LOCAL CANVASS. (a) Except as 6 provided by Subsection (b), each local canvassing authority shall 7 convene to conduct the local canvass at the time set by the 8 canvassing authority's presiding officer not earlier than the <u>11th</u> 9 [eighth] day or later than the <u>14th</u> [11th] day after election day.

10 (b) For an election held on the uniform election date in 11 May, the local canvass must occur not later than the <u>14th</u> [11th] day 12 after election day and not earlier than the later of:

the third day after election day;

14 (2) the date on which the early voting ballot board has
15 verified and counted all provisional ballots, if a provisional
16 ballot has been cast in the election; or

17 (3) the date on which all timely received ballots cast 18 from addresses outside of the United States are counted, if a ballot 19 to be voted by mail in the election was provided to a person outside 20 of the United States.

21 SECTION 5. Subchapter B, Chapter 85, Election Code, is 22 amended by adding Section 85.0312 to read as follows:

23 <u>Sec. 85.0312. REGISTRATION AT POLLING PLACE DURING EARLY</u> 24 <u>VOTING WITH PRESENTATION OF PHOTO IDENTIFICATION. (a) A person who</u> 25 <u>would be eligible to vote in an election under Section 11.001, but</u> 26 <u>for the requirement to be a registered voter, shall be accepted</u> 27 <u>during early voting by personal appearance for voting the ballot</u>

1	for the precinct of the person's residence as shown by the									
2	identification presented if, on the day the person offers to vote,									
3	the person:									
4	(1) submits a voter registration application that									
5	complies with Section 13.002 to an election officer at the polling									
6	place; and									
7	(2) presents as proof of residence a photo									
8	identification under Section 63.0101(a) that states the person's									
9	current address on the day the person seeks to vote.									
10	(b) The election officer shall return the original proof of									
11	residence to the voter.									
12	(c) A person voting under this section shall vote a									
13	provisional ballot in the manner provided by Section 63.011 except									
14	that the person is not required to submit the affidavit under									
15	Section 63.011(a).									
16	(d) For each registration corresponding to a ballot cast									
17	under this section, the voter registrar shall review the									
18	application and determine whether the applicant is eligible for									
19	registration as provided by Subchapter C, Chapter 13. The									
20	registrar shall inform the early voting ballot board of a									
21	determination made under this subsection. A registration approved									
22	under this subsection takes effect on the date the vote was cast.									
23	(e) The secretary of state may by rule:									
24	(1) designate additional documents that a person may									
25	offer to prove the person's residence to register and vote under									
26	this section; and									
27	(2) prescribe procedures to implement this section.
