- 5 SECTION 1. The heading to Chapter 8, Water Code, is amended
- 6 to read as follows:
- 7 CHAPTER 8. SOUTHWESTERN STATES WATER [MULTI-STATE WATER RESOURCES
- 8 PLANNING COMMISSION
- 9 SECTION 2. Section 8.001(1), Water Code, is amended to read
- 10 as follows:
- 11 (1) "Commission" means the Southwestern States Water
- 12 [Multi-State Water Resources Planning] Commission.
- SECTION 3. Section 8.011, Water Code, is amended to read as
- 14 follows:
- 15 Sec. 8.011. CREATION OF COMMISSION. The Southwestern
- 16 <u>States Water</u> [<u>Multi-State Water Resources Planning</u>] Commission is
- 17 created as an advisory commission to the governor and the
- 18 <u>legislature</u> [agency of the state].
- 19 SECTION 4. Section 8.013, Water Code, is amended to read as
- 20 follows:
- Sec. 8.013. COMMISSIONERS [MEMBERS OF COMMISSION];
- 22 APPOINTMENT. (a) The commission is composed of  $\underline{\text{three}}$  [seven]
- 23 commissioners as follows:
- 24 (1) [who are appointed by] the governor or the

- 1 governor's designee;
- 2 (2) a member of the standing committee of the house of
- 3 representatives that has jurisdiction over natural resources,
- 4 appointed by the governor; and
- 5 (3) a member of the standing committee [with the
- 6 advice and consent] of the senate that has jurisdiction over water
- 7 <u>issues</u>, appointed by the governor.
- 8 (b) The governor or the governor's designee shall act as the
- 9 official representative of this state on the commission and shall
- 10 exercise all powers and duties of this state as a member of the
- 11 commission [make the appointments so that each member is from a
- 12 different section of the state].
- 13 [(c) Three commissioners must be members of the general
- 14 public, one commissioner must have a background in the field of
- 15 higher education, one commissioner must have a background in
- 16 private business, one commissioner must have a background in
- 17 agriculture, and one commissioner must have a background in an
- 18 energy-related field.
- 19 SECTION 5. Section 8.015, Water Code, is amended to read as
- 20 follows:
- Sec. 8.015. TERMS [OF OFFICE]. (a) The two appointed
- 22 <u>commissioners serve</u> [<del>Commissioners hold office for</del>] staggered
- 23 terms of <u>four</u> [six] years, with the <u>term</u> [terms] of <u>one appointed</u>
- 24 commissioner [two or three commissioners] expiring on February 1 of
- 25 each odd-numbered year.
- 26 (b) Each appointed commissioner serves [holds office] until
- 27 the commissioner's [his] successor is appointed [and has qualified

- 1 for office].
- 2 (c)  $\underline{A}$  [If a] vacancy in an appointed position on the
- 3 commission [occurs in the office of commissioner, the governor]
- 4 shall be filled [appoint a successor to serve] for the unexpired
- 5 portion of the term in the same manner as the original appointment.
- 6 SECTION 6. Section 8.016, Water Code, is amended to read as
- 7 follows:
- 8 Sec. 8.016. CHAIRMAN. The governor or the governor's
- 9 designee shall serve [designate one commissioner] as chairman of
- 10 the commission [to serve at the will of the governor].
- SECTION 7. Section 8.017(c), Water Code, is amended to read
- 12 as follows:
- 13 (c) The chairman or two commissioners may call a special
- 14 meeting at any time by giving notice to the other commissioner or
- 15 commissioners.
- SECTION 8. Section 8.019, Water Code, is amended to read as
- 17 follows:
- 18 Sec. 8.019. ADMINISTRATIVE SUPPORT [STAFF]. The board
- 19 shall provide administrative [necessary staff and] support to the
- 20 commission to assist the commission in carrying out this chapter.
- 21 SECTION 9. Section 8.051, Water Code, is amended to read as
- 22 follows:
- Sec. 8.051. INTERACTION WITH OTHER STATES. (a) In
- 24 cooperation with representatives of neighboring states, the
- 25 commission <u>may discuss</u> [<del>shall study</del>] the water needs of the region
- 26 [after the year 2000].
- 27 (b) The commission may [shall] initiate and carry out

- 1 discussions with representatives of neighboring states relating to
- 2 the identification and development of sources and methods of
- 3 augmenting water supplies on a regional basis after existing water
- 4 supplies are fully committed.
- 5 SECTION 10. Section 8.052, Water Code, is amended to read as
- 6 follows:
- 7 Sec. 8.052. INTERACTION WITH MEXICO. The commission may
- 8 [shall contract and] confer with the government of Mexico
- 9 concerning water needs and development of sources of water supply.
- 10 SECTION 11. Section 8.056, Water Code, is amended to read as
- 11 follows:
- 12 Sec. 8.056. COMPACTS. The commission may [shall] contact
- 13 and negotiate with other states regarding the need for establishing
- 14 interstate compacts, addressing groundwater problems, needs, and
- 15 supplies, if an aquifer underlies several states, and addressing
- 16 other related subjects that would be beneficial to the states
- 17 including the conservation and beneficial use of water.
- 18 SECTION 12. Sections 8.014, 8.018, and 8.053, Water Code,
- 19 are repealed.
- 20 SECTION 13. (a) Promptly after this Act takes effect, the
- 21 governor shall appoint the initial appointed members of the
- 22 Southwestern States Water Commission under Chapter 8, Water Code,
- 23 as amended by this Act.
- 24 (b) In appointing the initial appointed members of the
- 25 commission, the governor shall appoint one person to a term
- 26 expiring February 1, 2017, and one person to a term expiring
- 27 February 1, 2019.
