2 SECTION 2. Subchapter A, Chapter 31, Election Code, is 3 amended by adding Section 31.013 to read as follows:

4 Sec. 31.013. PHOTO IDENTIFICATION ACCESS. The secretary of 5 state shall establish methods to obtain a photograph of each registered voter for use on the voter's voter registration 6 certificate. For purposes of this section, the secretary of state 7 8 shall enter into agreements with the Department of Public Safety and may enter into agreements with other state agencies and 9 10 governmental entities for assistance with assigning photographs to the appropriate voter's voter registration certificate. 11

12 SECTION 3. Section 63.0101, Election Code, is amended to 13 read as follows:

14Sec. 63.0101. DOCUMENTATIONOFPROOFOF15IDENTIFICATION. The following documentation is an acceptable form16of photo identification under this chapter:

(1) a driver's license, election identification certificate, or personal identification card issued to the person by the Department of Public Safety that has not expired or that expired no earlier than 60 days before the date of presentation;

(2) a United States military identification card that
 contains the person's photograph that has not expired or that
 expired no earlier than 60 days before the date of presentation;

24 (3) a United States citizenship certificate issued to25 the person that contains the person's photograph;

26 (4) a United States passport issued to the person that27 has not expired or that expired no earlier than 60 days before the

2 (5) a license to carry a concealed handgun issued to 3 the person by the Department of Public Safety that has not expired 4 or that expired no earlier than 60 days before the date of 5 presentation; or

6 (6) a voter's voter registration certificate
7 containing the voter's photograph.

8 SECTION 4. (a) As soon as practicable after the effective 9 date of this Act, the secretary of state shall establish, subject to 10 Subsection (b) of this section, the photo identification access 11 program required by Section 31.013, Election Code, as added by this 12 Act.

(b) The photo identification access program required by Section 31.013, Election Code, as added by this Act, must provide for voter registration certificates to contain photographs for use beginning with the general election for state and county officers held in 2016.
