A BILL TO BE ENTITLED

AN ACT

2	relating to exempting textbooks purchased, used, or consumed by
3	university and college students from the sales and use tax for
4	limited periods.
5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

- 6 SECTION 1. Subchapter H, Chapter 151, Tax Code, is amended
- 7 by adding Section 151.3211 to read as follows:
- 8 Sec. 151.3211. TEXTBOOKS PURCHASED, USED, OR CONSUMED BY
- 9 UNIVERSITY AND COLLEGE STUDENTS FOR LIMITED PERIODS. (a) The
- 10 sale, use, or consumption of a book written, designed, and produced
- 11 for educational, instructional, or pedagogical purposes is
- 12 <u>exempted from the taxes imposed by this chapter if:</u>
- 13 (1) the book is purchased by a full-time or part-time
- 14 student enrolled at an institution of higher education as defined
- 15 by Section 61.003, Education Code, or a private or independent
- 16 college or university that is located in this state and that is
- 17 accredited by a recognized accrediting agency as defined by Section
- 18 <u>61.003</u>, Education Code; and
- 19 (2) the purchase takes place at or after 12:01 a.m. on
- 20 the first day, but at or before 12 midnight on the last day, of an
- 21 <u>exemption period designated by the comptroller under Subsection</u>
- 22 (b).

- 23 (b) The comptroller shall designate seven consecutive days
- 24 in January and seven consecutive days in August of each year during

- 1 which the exemption authorized by this section is effective. The
- 2 comptroller shall designate each exemption period for the time in
- 3 the relevant month when the greatest number of books described by
- 4 Subsection (a) is likely to be purchased, as determined by the
- 5 comptroller based on a review of the academic calendars of the
- 6 institutions of higher education, colleges, and universities
- 7 described by Subsection (a)(1). The comptroller shall designate the
- 8 exemption period in a manner and at a time that provides reasonable
- 9 notice of the exemption period to retailers and the public.
- 10 (c) A person may establish that the person is a full-time or
- 11 part-time student by presenting a valid student identification
- 12 card. The comptroller by rule shall prescribe the manner in which a
- 13 person may electronically establish, when making an online
- 14 purchase, that the person is a full-time or part-time student.
- 15 SECTION 2. The change in law made by this Act does not
- 16 affect taxes imposed before the effective date of this Act, and the
- 17 law in effect before the effective date of this Act is continued in
- 18 effect for purposes of the liability for and collection of those
- 19 taxes.
- 20 SECTION 3. This Act takes effect July 1, 2015, if it
- 21 receives a vote of two-thirds of all the members elected to each
- 22 house, as provided by Section 39, Article III, Texas Constitution.
- 23 If this Act does not receive the vote necessary for effect on that
- 24 date, this Act takes effect October 1, 2015.
