## A BILL TO BE ENTITLED

1 AN ACT

2 relating to the growth or cultivation of industrial hemp for

- 3 certain research purposes.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Chapter 12, Agriculture Code, is amended by
- 6 adding Section 12.050 to read as follows:
- 7 Sec. 12.050. INDUSTRIAL HEMP RESEARCH. (a) In this
- 8 section:
- 9 (1) "Industrial hemp" means the plant Cannabis sativa
- 10 L. and any part of that plant, whether growing or not, with a
- 11 delta-9 tetrahydrocannabinol concentration of not more than 0.3
- 12 percent on a dry weight basis.
- 13 (2) "Institution of higher education" has the meaning
- 14 assigned by 20 U.S.C. Section 1001.
- 15 (b) The department or an institution of higher education may
- 16 grow or cultivate industrial hemp as provided by 7 U.S.C. Section
- 17 5940.
- (c) A person does not violate Section 481.120, 481.121, or
- 19 481.125, Health and Safety Code, if the person grows, cultivates,
- 20 manufactures, delivers, or possesses industrial hemp, or
- 21 manufactures, delivers, or possesses paraphernalia used for the
- 22 cultivation or processing of industrial hemp, as part of research
- 23 allowed under Subsection (b) and the person is:
- 24 (1) the department or an institution of higher

- 3 (2) an employee, student, or other person affiliated
- 4 with the department or an institution of higher education
- 5 participating in research allowed under Subsection (b).
- 6 SECTION 2. Section 481.062(a), Health and Safety Code, as
- 7 amended by S.B. No. 219, Acts of the 84th Legislature, Regular
- 8 Session, 2015, is amended to read as follows:
- 9 (a) The following persons are not required to register and
- 10 may possess a controlled substance under this chapter:
- 11 (1) an agent or employee of a registered manufacturer,
- 12 distributor, analyzer, or dispenser of the controlled substance
- 13 acting in the usual course of business or employment;
- 14 (2) a common or contract carrier, a warehouseman, or
- 15 an employee of a carrier or warehouseman whose possession of the
- 16 controlled substance is in the usual course of business or
- 17 employment;
- 18 (3) an ultimate user or a person in possession of the
- 19 controlled substance under a lawful order of a practitioner or in
- 20 lawful possession of the controlled substance if it is listed in
- 21 Schedule V;
- 22 (4) an officer or employee of this state, another
- 23 state, a political subdivision of this state or another state, or
- 24 the United States who is lawfully engaged in the enforcement of a
- 25 law relating to a controlled substance or drug or to a customs law
- 26 and authorized to possess the controlled substance in the discharge
- 27 of the person's official duties; [or]

- 1 (5) if the substance is tetrahydrocannabinol or one of
- 2 its derivatives:
- 3 (A) a Department of State Health Services
- 4 official, a medical school researcher, or a research program
- 5 participant possessing the substance as authorized under
- 6 Subchapter G; or
- 7 (B) a practitioner or an ultimate user possessing
- 8 the substance as a participant in a federally approved therapeutic
- 9 research program that the commissioner has reviewed and found, in
- 10 writing, to contain a medically responsible research protocol; or
- 11 (6) if the substance is industrial hemp, as defined by
- 12 Section 12.050, Agriculture Code, the Department of Agriculture or
- 13 <u>an institution of higher education participating in research</u>
- 14 allowed under Section 12.050, Agriculture Code, or an employee,
- 15 student, or other person affiliated with the Department of
- 16 Agriculture or the institution of higher education participating in
- 17 that research.
- 18 SECTION 3. This Act takes effect immediately if it receives
- 19 a vote of two-thirds of all the members elected to each house, as
- 20 provided by Section 39, Article III, Texas Constitution. If this
- 21 Act does not receive the vote necessary for immediate effect, this
- 22 Act takes effect September 1, 2015.
