Article 12.03(d), Code of Criminal Procedure, is amended to read as follows: 7 8 (d) Any [Except as otherwise provided by this chapter, any] 9 offense that bears the title "aggravated" shall carry the same 10 limitation period as the primary crime if a limitation period has not otherwise been specifically provided for the aggravated offense 11 12 under another provision of this chapter. SECTION 3. The change in law made by this Act does not apply 13 to an offense if the prosecution of that offense becomes barred by 14 15 limitation before the effective date of this Act. The prosecution of that offense remains barred as if this Act had not taken effect. 16

SECTION 4. This Act takes effect September 1, 2015.
