A BILL TO BE ENTITLED 1 AN ACT 2 relating to the requirements for an official carrier envelope for a 3 ballot to be voted by mail and materials accompanying the official carrier envelope. 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 5 6 SECTION 1. Sections 86.013(c), (d), and (g), Election Code, 7 are amended to read as follows: (c) A certificate in substantially the following form must 8 be printed on the reverse side of the official carrier envelope in a 9 manner that requires the voter to sign across the flap of the 10 11 envelope: 12 "I certify that the enclosed ballot expresses my wishes 13 independent of any dictation or undue persuasion by any person. 14 15 Signature of voter 16 By: ____ 17 Signature of person assisting voter, if applicable (see Ballot 18 Envelope for restrictions 19 and 20 penalties) 21 22 Printed name of person assisting 23 voter, if applicable 24

No. 732 1 Residence address of person 2 assisting voter, if applicable" 3 The space provided for the voter's signature must be located in a box that is at least one inch by two inches, and "Signature of 4 5 voter" must be printed in bold type. 6 The following textual material, as prescribed by the (d) secretary of state, must be printed [on the reverse side of the 7 official carrier envelope or] on a separate sheet accompanying the 8 carrier envelope [when it is provided]: 9 10 (1)the prohibition prescribed by Section 86.006(b); the conditions for delivery by common or contract 11 (2) carrier prescribed by Sections 81.005 and 86.006; 12 (3) the requirements for the legal execution and 13 14 delivery of the carrier envelope, including the prohibition on 15 compensation for depositing carrier envelopes containing ballots voted by other persons under Section 86.0052; 16 17 (4) the prohibition prescribed by Section 86.006(e); and 18 the offenses prescribed by Sections 86.006(f) and 19 (5) 86.010(f). 20 The secretary of state by rule shall require that a 21 (q) notice informing voters of the telephone number established under 22 23 Section 31.0055 and the purpose of the telephone number be printed 24 on[÷ 25 [(1) the official carrier envelope; or 26 $\left[\frac{(2)}{2}\right]$ an insert enclosed with the balloting materials

for voting by mail sent to the voter.

1 SECTION 2. The changes in law made by this Act apply only to 2 an election ordered on or after the effective date of this Act. An 3 election ordered before the effective date of this Act is governed 4 by the law in effect when the election was ordered, and the former 5 law is continued in effect for that purpose.

6 SECTION 3. This Act takes effect September 1, 2015.
