5	SECTION 1. Section 108.009, Health and Safety Code, is
6	amended by adding Subsection (c) to read as follows:
7	(c) The department or another entity as determined by the
8	department to collect data from a provider under Subsection (a)
9	shall maintain a database that does not include identifying
10	information for use as authorized by law, including this chapter.
11	SECTION 2. Chapter 108, Health and Safety Code, is amended
12	by adding Section 108.0095 to read as follows:
13	Sec. 108.0095. NOTIFICATION OF DATA COLLECTION. (a) A
14	provider shall provide to a patient whose data is being collected
15	under this chapter written notice on a form prescribed by the
16	department of the collection of the patient's data for health care
17	purposes.
18	(b) The notice provided under this section must include the
19	name of the agency or entity receiving the data and of an individual
20	within the agency or entity whom the patient may contact regarding
21	the collection of data.
22	(c) The department shall include the notice required under
23	this section on an existing department form and make the form
24	available on the department's Internet website.

SECTION 3. Section 108.011(d), Health and Safety Code, as
amended by S.B. 219, Acts of the 84th Legislature, Regular Session,
2015, is amended to read as follows:

4 (d) The executive commissioner shall adopt procedures to 5 establish the accuracy and consistency of the public use data before releasing the public use data to the public. The department 6 may adopt additional procedures as the department determines 7 8 necessary. The procedures adopted under this subsection must meet available best practices and national standards for public research 9 10 on and consumer use of health care data collected by governmental agencies. 11

SECTION 4. Section 108.013(a), Health and Safety Code, as amended by S.B. 219, Acts of the 84th Legislature, Regular Session, 2015, is amended to read as follows:

15 (a) The data received by the department under this chapter shall be used by the department and commission only for the benefit 16 17 of the public. Subject to specific limitations established by this and department rule, the department 18 chapter shall make determinations on requests for information in favor of access. 19

20 SECTION 5. Chapter 108, Health and Safety Code, is amended 21 by adding Section 108.0132 to read as follows:

22 <u>Sec. 108.0132.</u> PROHIBITED CHARGE TO CERTAIN STATE AGENCIES 23 FOR DATA. The department may not charge a fee to the commission or 24 any other health and human services agency for the use of any data 25 <u>collected under this chapter.</u>

26 SECTION 6. Chapter 108, Health and Safety Code, is amended 27 by adding Section 108.0136 to read as follows:

1	Sec. 108.0136. REPORT; NOTIFICATION OF CYBER ATTACK. (a)
2	The department shall prepare for the commissioner an annual report
3	describing the security measures taken to protect data collected
4	under this chapter and any breaches, attempted cyber attacks, and
5	security issues related to the data that are encountered during the
6	calendar year.
7	(b) The report described by this section is not subject to
8	Chapter 552, Government Code, but may be released on request to a
9	member of the legislature.
10	(c) If a cyber attack occurs targeting data collected under
11	this chapter, the department shall notify the Department of Public
12	Safety of the State of Texas and the Federal Bureau of Investigation
13	of the attack.
14	SECTION 7. This Act takes effect September 1, 2015.
