1 certificate, on or after the effective date of this Act. A form
2 used before the effective date of this Act is governed by the law as
3 it existed immediately before that date, and that law is continued
4 in effect for that purpose.

5 SECTION 5. This Act takes effect immediately if it receives 6 a vote of two-thirds of all the members elected to each house, as 7 provided by Section 39, Article III, Texas Constitution. If this 8 Act does not receive the vote necessary for immediate effect, this 9 Act takes effect September 1, 2015.
