A BILL TO BE ENTITLED

AN ACT

relating to authorization for a caregiver who is a relative to enroll a child in school.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Subtitle E, Title 2, Education Code, is amended by adding Chapter 27 to read as follows:

CHAPTER 27. RIGHTS OF CERTAIN RELATIVE CAREGIVERS TO ENROLL CHILD
IN SCHOOL

Sec. 27.001. DEFINITION. In this chapter, "relative" means someone related to a child by consanguinity or affinity, as determined under Sections 573.022 and 573.024, Government Code, respectively.

Sec. 27.002. AFFIDAVIT OF CAREGIVER. (a) A caregiver of a child who is a relative of the child may execute an affidavit indicating that:

(1) the child primarily resides with the caregiver;
and

(2) the caregiver made a reasonably diligent effort but was unable to locate or contact the child's parent or legal guardian for authorization.

(b) The affidavit must be witnessed by two witnesses who are at least 18 years of age or older and at least one of whom is not related by blood or marriage to the child or the caregiver.

(c) The completed affidavit must be notarized.

Sec. 27.003. RIGHTS AND DUTIES OF CHILD AND CAREGIVER. (a)

A caregiver may provide the affidavit under this chapter to a school or school district to enroll the child in school.

(b) If the child no longer resides with the caregiver or if the child's parent or legal guardian objects to the caregiver's authorization, the affidavit is invalid and the caregiver shall notify all parties to whom the caregiver provided the affidavit, including the child's school.

Sec. 27.004. EFFECT OF AFFIDAVIT. (a) A person who relies on an affidavit that complies with this chapter has no obligation to make any further inquiry or investigation.

(b) The caregiver's authorization affidavit does not affect the rights of the child's parent or legal guardian regarding the care, custody, and control of the child and does not mean that the caregiver has legal custody of the child.

(c) A caregiver's authorization affidavit executed under this chapter does not confer or affect standing or a right of intervention in any proceeding under Title 5, Family Code.

Sec. 27.005. FORM OF AFFIDAVIT. The caregiver's authorization affidavit must be in substantially the following form:

Caregiver's Authorization Affidavit

Use of this affidavit is authorized by Chapter 27, Education Code.

Instructions: Completion of and the signing of the affidavit are sufficient to authorize enrollment of a child in school. Print clearly.

1. This declaration does not affect the rights of the child's parents or legal guardian regarding the care, custody, and control of the child and does not mean that the caregiver has legal custody of the child.

2. A person who relies on this affidavit has no obligation to make any further inquiry or investigation.

Additional Information:

TO CAREGIVERS:

1. "Qualified relative," for purposes of Item 5 of the

1 affidavit, means a person related to the child by consanguinity or
2 affinity (blood, marriage, or adoption).

3 2. If the child no longer resides with you or if the child's
4 parent or guardian objects to this authorization, you are required
5 to notify any school to which you have given this affidavit. The
6 affidavit is invalid after the school receives notice.

7 TO SCHOOL OFFICIALS:

8 1. Section 25.001, Education Code, provides that this
9 affidavit constitutes a sufficient basis for a determination of
10 residency of the child unless the school district determines from
11 actual facts that the child is not living with the caregiver.

12 2. The school district may require additional reasonable
13 evidence that the caregiver lives at the address provided in Item 4
14 of the affidavit.

15 Sec. 27.006. RULES. (a) The commissioner shall adopt rules
16 to implement this chapter and to ensure that the caregiver's
17 authorization affidavit is accepted by schools and school
18 districts.

19 (b) The agency shall develop the form required by Section
20 27.005 and make that form available on the agency's Internet
21 website.

22 Sec. 27.007. OTHER ENROLLMENT PROVISIONS NOT AFFECTED. The
23 provisions in this chapter for enrolling a student into the public
24 schools free of tuition are in addition to and do not affect
25 enrollment provisions under other law, including provisions under
26 Section 25.001(b) that do not refer to a caregiver's authorization
27 affidavit.

SECTION 2. Section 25.001, Education Code, is amended by amending Subsection (b) and adding Subsection (d-1) to read as follows:

(b) The board of trustees of a school district or its designee shall admit into the public schools of the district free of tuition a person who is over five and younger than 21 years of age on the first day of September of the school year in which admission is sought, and may admit a person who is at least 21 years of age and under 26 years of age for the purpose of completing the requirements for a high school diploma, if:

(1) the person and either parent of the person reside in the school district;

(2) the person does not reside in the school district but a parent of the person resides in the school district and that parent is a joint managing conservator or the sole managing conservator or possessory conservator of the person;

(3) the person and the person's guardian or other person having lawful control of the person under a court order reside within the school district;

(4) the person has established a separate residence under Subsection (d);

(5) the person is homeless, as defined by 42 U.S.C. Section 11302, regardless of the residence of the person, of either parent of the person, or of the person's guardian or other person having lawful control of the person;

(6) the person is a foreign exchange student placed with a host family that resides in the school district by a

1 nationally recognized foreign exchange program, unless the school
2 district has applied for and been granted a waiver by the
3 commissioner under Subsection (e);

4 (7) the person resides at a residential facility
5 located in the district;

6 (8) the person resides in the school district and is 18
7 years of age or older or the person's disabilities of minority have
8 been removed; ~~[or]~~

9 (9) the person does not reside in the school district
10 but the grandparent of the person:

11 (A) resides in the school district; and

12 (B) provides a substantial amount of
13 after-school care for the person as determined by the board; or

14 (10) the person lives with a relative who resides in
15 the school district and submits to the district a caregiver's
16 authorization affidavit executed under Chapter 27 of this code or
17 an authorization agreement executed under Chapter 34, Family Code.

18 (d-1) For purposes of establishing eligibility for
19 admission into the public schools of a district free of tuition
20 under this section, the submission of a caregiver's authorization
21 affidavit or authorization agreement under Subsection (b)(10) is
22 not the exclusive method by which a person under the age of 18 years
23 may establish a residence separate and apart from the person's
24 parent, guardian, or other person having lawful control of the
25 person under a court order.

26 SECTION 3. Section 25.002(f), Education Code, is amended to
27 read as follows:

1 (f) Unless a child is authorized by Section 25.001(b)(4) or
2 (5) or other law to enroll without the participation of another
3 person, a ~~[Except as otherwise provided by this subsection, for a~~
4 ~~child to be enrolled in a public school, the child must be enrolled~~
5 ~~by the child's parent or by the child's guardian or other person~~
6 ~~with legal control of the child under a court order. A]~~ school
7 district shall record the name, address, and date of birth of the
8 person enrolling the ~~[a]~~ child.

9 SECTION 4. Section 26.002, Education Code, is amended to
10 read as follows:

11 Sec. 26.002. DEFINITION. In this chapter, "parent"
12 includes a person standing in parental relation. The term includes
13 a relative with whom the child resides and who is authorized to
14 enroll the child in school pursuant to a caregiver's authorization
15 affidavit executed under Chapter 27 of this code or an
16 authorization agreement executed under Chapter 34, Family Code. The
17 term does not include a person as to whom the parent-child
18 relationship has been terminated or a person not entitled to
19 possession of or access to a child under a court order. Except as
20 provided by federal law, all rights of a parent under Title 2 of
21 this code and all educational rights under Section 151.001(a)(10)
22 ~~[151.003(a)(10)]~~, Family Code, shall be exercised by a student who
23 is 18 years of age or older or whose disabilities of minority have
24 been removed for general purposes under Chapter 31, Family Code,
25 unless the student has been determined to be incompetent or the
26 student's rights have been otherwise restricted by a court order.

27 SECTION 5. Sections 25.001, 25.002, and 26.002, Education

1 Code, as amended by this Act, apply beginning with the 2015-2016
2 school year.

3 SECTION 6. This Act takes effect immediately if it receives
4 a vote of two-thirds of all the members elected to each house, as
5 provided by Section 39, Article III, Texas Constitution. If this
6 Act does not receive the vote necessary for immediate effect, this
7 Act takes effect September 1, 2015.
