- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 231.302, Family Code, is amended by
- 6 amending Subsection (c) and adding Subsection (c-2) to read as
- 7 follows:
- 8 (c) Except as provided by Subsection (c-1) or (c-2), to
- 9 assist in the administration of laws relating to child support
- 10 enforcement under Parts A and D of Title IV of the federal Social
- 11 Security Act (42 U.S.C. Section 601 et seq. [Sections 601-617] and
- 12 <u>42 U.S.C. Section 651 et seq.</u> [651-669]):
- 13 (1) each licensing authority shall request and each
- 14 applicant for a license shall provide the applicant's social
- 15 security number;
- 16 (2) each agency administering a contract that provides
- 17 for a payment of state funds shall request and each individual or
- 18 entity bidding on a state contract shall provide the individual's
- 19 or entity's social security number as required by Section 231.006;
- 20 and
- 21 (3) each agency administering a state-funded grant or
- 22 loan program shall request and each applicant for a grant or loan
- 23 shall provide the applicant's social security number as required by
- 24 Section 231.006.

- 1 (c-2) For purposes of issuing a fishing or hunting license,
- 2 the Texas Parks and Wildlife Department is not required to request,
- 3 and an applicant is not <u>required to provide</u>, the applicant's social
- 4 security number if the applicant is 13 years of age or younger.
- 5 SECTION 2. Subchapter A, Chapter 11, Parks and Wildlife
- 6 Code, is amended by adding Section 11.005 to read as follows:
- 7 Sec. 11.005. SOCIAL SECURITY NUMBERS OF CERTAIN MINORS.
- 8 (a) The commission may not adopt rules that require a person 13
- 9 years of age or younger who applies for a license under Chapter 42,
- 10 46, or 50 to provide the applicant's social security number.
- 11 (b) The commission may adopt a rule requiring an applicant
- 12 described by Subsection (a) or the applicant's parent or guardian
- 13 to sign a statement that the applicant is not an obligor subject to
- 14 a child support order.
- SECTION 3. Not later than December 1, 2015, the Texas Parks
- 16 and Wildlife Commission shall adopt any necessary rules to
- 17 implement this Act.
- 18 SECTION 4. The change in law made by this Act applies only
- 19 to an application for a hunting or fishing license that is submitted
- 20 on or after January 1, 2016. An application submitted before that
- 21 date is governed by the law in effect immediately before the
- 22 effective date of this Act, and the former law is continued in
- 23 effect for that purpose.
- SECTION 5. This Act takes effect September 1, 2015.
