18	under conditions other than dishonorable.
19	Sec. 434.202. ESTABLISHMENT OF PROGRAM; PROGRAM MISSION.
20	(a) The Texas Women Veterans Program is established in the
21	commission. The program is attached to the office of the executive
22	director for administrative purposes.
23	(b) The mission of the program is to ensure that the women
24	veterans of this state have equitable access to federal and state

1 veterans' benefits and services. 2 Sec. 434.203. COORDINATOR. The executive director shall 3 designate a women veterans coordinator for this state. 4 Sec. 434.204. GENERAL PROGRAM DUTIES. The program shall: 5 (1) provide assistance to the women veterans of this state as provided by this subchapter; 6 7 (2) perform outreach functions to improve the 8 awareness of women veterans of their eligibility for federal and state veterans' benefits and services; 9 10 (3) assess the needs of women veterans with respect to benefits and services; 11 12 (4) review programs, research projects, and other initiatives designed to address the needs of the women veterans of 13 14 this state; 15 (5) make recommendations to the executive director regarding the improvement of benefits and services to women 16 17 veterans; and (6) incorporate issues concerning women veterans in 18 19 commission planning regarding veterans' benefits and services. Sec. 434.205. ADVOCACY AND PUBLIC AWARENESS. (a) 20 The program shall advocate for women veterans and work to increase 21 public awareness about the gender-specific needs of women veterans. 22 (b) The program shall recommend legislative initiatives and 23 24 the development of policies on the local, state, and national levels to address the issues affecting women veterans. 25 26 Sec. 434.206. COLLABORATION. The program shall collaborate with federal, state, county, municipal, and private agencies that 27

2	Sec. 434.207. RESEARCH; DISSEMINATION OF INFORMATION. (a)
3	The program shall monitor and research issues relating to women
4	veterans.
5	(b) The program shall disseminate information regarding
6	opportunities for women veterans throughout the network of entities
7	with which the program collaborates.
8	Sec. 434.208. EDUCATION. Through conferences, seminars,
9	and training workshops with federal, state, county, municipal, and
10	private agencies, the program shall provide guidance and direction
11	to a woman veteran who is applying for grants, benefits, or
12	services.
13	Sec. 434.209. HONOR AND RECOGNITION. The program shall
14	promote events and activities that recognize and honor the women
15	veterans of this state and women who serve in the military.
16	Sec. 434.210. FACILITIES. To the extent funding is
17	available for that purpose, the program shall provide facilities as
18	appropriate in support of the program.
19	Sec. 434.211. FUNDING; GRANTS. On behalf of the program,
20	the commission may:
21	(1) accept and spend funds:
22	(A) appropriated to the commission for the
23	operation of the program; and
24	(B) received from other sources, including
25	donations and grants; and
26	(2) provide matching grants to assist in the
27	implementation of the program's goals and objectives.

H.B. No. 867 1 SECTION 2. Section 434.017(e), Government Code, is amended 2 to read as follows:

3 (e) To carry out any purpose of this chapter, the commission may solicit, accept, or refuse a gift, grant, devise, bequest of 4 money, security, service, or property, including money raised or a 5 service provided by a volunteer or volunteer group, to promote the 6 work of the commission for any purpose related to the fund for 7 8 veterans' assistance. The commission may participate in the affiliated nonprofit establishment and operation of an 9 organization that is established for the purpose of raising money 10 for or providing services or other benefits to the commission or a 11 12 program established in the commission, including the Texas Women Veterans Program. A gift, grant, devise, or bequest to the fund may 13 14 be appropriated in the same manner as other money in the fund, subject to the purposes provided by Subsection (c) and any 15 limitation or requirement placed on the gift, grant, devise, or 16 17 bequest by the donor or granting entity.

18 SECTION 3. This Act takes effect immediately if it receives 19 a vote of two-thirds of all the members elected to each house, as 20 provided by Section 39, Article III, Texas Constitution. If this 21 Act does not receive the vote necessary for immediate effect, this 22 Act takes effect September 1, 2015.
