20	(a) The Texas Women Veterans Program is established in the

- 8 Sec. 434.208. EDUCATION. Through conferences, seminars,

- 13 Sec. 434.209. HONOR AND RECOGNITION. The program shall

1 SECTION 2. Section 434.017(e), Government Code, is amended 2 to read as follows:

3 To carry out any purpose of this chapter, the commission may solicit, accept, or refuse a gift, grant, devise, bequest of 4 money, security, service, or property, including money raised or a 5 service provided by a volunteer or volunteer group, to promote the 6 work of the commission for any purpose related to the fund for 7 8 veterans' assistance. The commission may participate in the establishment and operation of an affiliated nonprofit organization that is established for the purpose of raising money 10 for or providing services or other benefits to the commission or a 11 12 program established in the commission, including the Texas Women Veterans Program. A gift, grant, devise, or bequest to the fund may 13 14 be appropriated in the same manner as other money in the fund, subject to the purposes provided by Subsection (c) and any 15 limitation or requirement placed on the gift, grant, devise, or 16 17 bequest by the donor or granting entity.

SECTION 3. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2015.
