6	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
7	SECTION 1. Subchapter C, Chapter 61, Education Code, is
8	amended by adding Section 61.07612 to read as follows:
9	Sec. 61.07612. STUDY ON QUALIFICATION AND PERFORMANCE OF
10	HIGH SCHOOL STUDENTS COMPLETING CERTAIN MATHEMATICS COURSES. (a)
11	Each academic year, the board shall conduct a study regarding the
12	qualification for and performance at institutions of higher
13	education of students graduating from school districts in
14	low-income areas, as defined by the board, who completed certain
15	mathematics courses during high school.
16	(b) The study must include a comparison of:
17	(1) acceptance rates at institutions of higher
18	education between students who, under the foundation high school

- (d) The board shall adopt rules as necessary to implement
- 23 this section in a manner that ensures compliance with federal law
- 24 regarding confidentiality of student educational information,
- 25 including the Family Educational Rights and Privacy Act of 1974 (20
- 26 U.S.C. Section 1232g).
- (e) This section expires December 1, 2019.

SECTION 2. Not later than September 1, 2016, the Texas
Higher Education Coordinating Board shall submit its initial report
required by Section 61.07612, Education Code, as added by this Act.

SECTION 3. This Act takes effect immediately if it receives
a vote of two-thirds of all the members elected to each house, as
provided by Section 39, Article III, Texas Constitution. If this
Act does not receive the vote necessary for immediate effect, this
Act takes effect September 1, 2015.
