## A BILL TO BE ENTITLED

1	AN ACT
2	relating to charitable raffles conducted by certain professional
3	sports team charitable foundations; providing penalties.
4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subtitle A, Title 13, Occupations Code, is
6	amended by adding Chapter 2004 to read as follows:
7	CHAPTER 2004. PROFESSIONAL SPORTS TEAM CHARITABLE
8	FOUNDATION RAFFLES
9	Sec. 2004.001. SHORT TITLE. This chapter may be cited as
10	the Professional Sports Team Charitable Foundation Raffle Enabling
11	Act.
12	Sec. 2004.002. DEFINITIONS. In this chapter:
13	(1) "Charitable purposes" has the meaning assigned by
14	Section 2002.002.
15	(2) "Professional sports team" means a team organized
16	in this state that is a member of Major League Baseball, the
17	National Basketball Association, the National Hockey League, the
18	National Football League, or Major League Soccer.
19	(3) "Professional sports team charitable foundation"
20	means an organization that:
21	(A) holds a certificate of formation under the
22	Business Organizations Code or is otherwise incorporated under the
23	laws of this state;

(B) is associated with a professional sports

1 team; and 2 (C) is formed for charitable purposes. (4) "Raffle" has the meaning assigned by Section 3 4 2002.002. 5 Sec. 2004.003. QUALIFICATIONS TO CONDUCT RAFFLE. professional sports team charitable foundation is qualified to 6 7 conduct charitable raffles under this chapter if the foundation: 8 (1) is associated with a professional sports team with a home venue located in this state; 9 10 (2) does not distribute any of its income to its members, officers, or governing body, other than as reasonable 11 12 compensation for services; (3) has existed for at least the three years preceding 13 14 the conduct of a raffle under this chapter; 15 (4) does not devote a substantial part of its activities to attempting to influence legislation and does not 16 17 participate or intervene in any political campaign on behalf of any candidate for public office in any manner, including by publishing 18 19 or distributing statements or making campaign contributions; (5) qualifies for and has obtained an exemption from 20 21 federal income tax from the Internal Revenue Service as a charitable organization described in Section 501(c)(3), Internal 22 Revenue Code of 1986; and 23 24 (6) does not have or recognize any local chapter, 25 affiliate, unit, or subsidiary organization in this state. 26 Sec. 2004.004. RAFFLE AUTHORIZED; TICKET SALES. (a) A

professional sports team charitable foundation that meets the

- 1 qualifications under Section 2004.003 may conduct a charitable
- 2 raffle during each preseason, regular season, and postseason game
- 3 hosted at the home venue of the professional sports team associated
- 4 with the foundation to provide revenue for the foundation's
- 5 charitable purposes.
- 6 (b) A professional sports team charitable foundation
- 7 authorized to conduct a raffle under this section may award to a
- 8 raffle winner selected by random draw a cash prize in an amount not
- 9 to exceed 50 percent of the gross proceeds collected from the sale
- 10 of raffle tickets.
- 11 (c) Only employees or volunteers of the professional sports
- 12 team charitable foundation or the professional sports team
- 13 associated with the foundation may sell raffle tickets for a
- 14 charitable raffle conducted under this chapter.
- 15 <u>(d) Only persons 18 years of age or older may purchase</u>
- 16 raffle tickets in a charitable raffle conducted under this chapter.
- 17 Sec. 2004.005. TICKET DISCLOSURES. The following
- 18 <u>information must be printed on each raffle ticket sold or offered</u>
- 19 for sale under this chapter:
- 20 (1) the name of the raffle for which the ticket is
- 21 offered for sale and the sales station at which the ticket was
- 22 purchased;
- 23 (2) the date on which the random draw to determine the
- 24 winner of the raffle will occur and the manner in which the winning
- 25 ticket for the raffle will be announced;
- 26 (3) the procedure and location for claiming a prize;
- 27 (4) the time allowed for a prize winner to claim a

1 prize; and 2 (5) the logo of the professional sports team charitable foundation, the logo of the professional sports team 3 associated with the foundation, or both. 4 5 Sec. 2004.006. USE OF RAFFLE PROCEEDS. All proceeds from the sale of raffle tickets less the amounts deducted for reasonable 6 7 operating expenses and cash prizes must be used for the charitable 8 purposes of the professional sports team charitable foundation. 9 Sec. 2004.007. REASONABLE OPERATING EXPENSES. (a) For each raffle conducted under this chapter, a professional sports team 10 charitable foundation may deduct not more than 10 percent of the 11 12 gross proceeds collected from the sale of tickets for the raffle to pay the reasonable operating expenses of conducting the raffle. 13 (b) For purposes of this chapter, reasonable operating 14 15 expenses include: 16 (1) promotion, advertisements, charitable foundation 17 fund-raising events, equipment, and administrative expenses; and (2) purchase, lease, or licensing fees for the 18 19 equipment, hardware, and software necessary to: 20 (A) sell raffle tickets to raffle participants; 21 (B) conduct random drawings to select prize 22 winners; and (C) continuously calculate the number of ticket

sales, amount of money collected, amount of cash prize to be

awarded, amount of money raised for charitable purposes, and amount

of gross ticket sales that may be deducted for reasonable operating

expenses.

- 1 Sec. 2004.008. CRIMINAL PENALTIES. (a) A person commits an
- 2 offense if the person accepts any form of payment other than United
- 3 States currency for the purchase of a raffle ticket for a charitable
- 4 raffle conducted under this chapter.
- 5 (b) A person commits an offense if the person sells or
- 6 offers to sell a raffle ticket for a charitable raffle conducted
- 7 under this chapter to an individual that the person knows to be
- 8 younger than 18 years of age.
- 9 (c) A person commits an offense if the person purchases a
- 10 raffle ticket for a charitable raffle conducted under this chapter
- 11 with the proceeds of a check issued as a payment under the financial
- 12 assistance program administered under Chapter 31, Human Resources
- 13 Code.
- 14 (d) A person commits an offense if the person misrepresents
- 15 the person's age or displays fraudulent evidence that the person is
- 16 18 years of age or older in order to purchase a raffle ticket for a
- 17 charitable raffle conducted under this chapter.
- 18 (e) An offense under this section is a Class C misdemeanor.
- 19 Sec. 2004.009. INJUNCTIVE ACTION AGAINST UNAUTHORIZED
- 20 RAFFLE. (a) A county attorney, district attorney, criminal
- 21 district attorney, or the attorney general may bring an action in
- 22 county or district court for a permanent or temporary injunction or
- 23 a temporary restraining order prohibiting conduct involving a
- 24 raffle or similar procedure that:
- 25 (1) violates or threatens to violate state law
- 26 relating to gambling; and
- 27 (2) is not authorized by this chapter, Chapter 2002,

- 1 or other law.
- 2 (b) Venue for an action under this section is in the county
- 3 in which the conduct occurs or in which a defendant in the action
- 4 resides.
- 5 SECTION 2. Section 47.02(c), Penal Code, is amended to read

- 22 or other recreational event conducted by the Parks and Wildlife
