5	SECTION 1. Subchapter B, Chapter 531, Government Code, is
6	amended by adding Subsection 531.02116 to read as follows:
7	Sec. 531.02116. ADMINISTRATIVE AND JUDICIAL REVIEW OF
8	REIMBURSEMENT DISPUTES UNDER MEDICAID PROGRAM. (a) A provider has
9	the right to a contested case hearing to dispute the amount of a
10	reimbursement rate paid to the provider under the fee-for-service
11	Medicaid program or by a managed care organization under the
12	managed care Medicaid program if the provider maintains that the
13	rate is below the rate necessary to recover the provider's
14	reasonable operating expenses and to realize a reasonable return or
15	the provider's investments that is sufficient to ensure confidence
16	in the provider's continued financial integrity.
17	(b) A contested case hearing under this section must be
18	conducted by a hearing officer in the manner provided for contested
19	case hearings under Subchapter C, Chapter 2001.
20	(c) Parties to a contested case hearing under this section

- 7 <u>(f) Judicial review of a decision or order of a hearing</u>
- 8 officer is governed by Subchapter G, Chapter 2001, except that the
- 9 party seeking judicial review must file suit not later than the 45th
- 10 day after the date notice of the decision made by the hearing
- 11 officer was mailed.
- 12 SECTION 2. The change in law made by this Act applies only
- 13 to a reimbursement paid to a Medicaid provider on or after the
- 14 effective date of this Act.
- SECTION 3. If before implementing any provision of this Act
- 16 a state agency determines that a waiver or authorization from a
- 17 federal agency is necessary for implementation of that provision,
- 18 the agency affected by the provision shall request the waiver or
- 19 authorization and may delay implementing that provision until the
- 20 waiver or authorization is granted.
- 21 SECTION 4. This Act takes effect immediately if it receives
- 22 a vote of two-thirds of all the members elected to each house, as
- 23 provided by Section 39, Article III, Texas Constitution. If this
- 24 Act does not receive the vote necessary for immediate effect, this
- 25 Act takes effect September 1, 2015.
