Section 1802.002(a), Occupations 4 Code, is 5 amended to read as follows: 6 This chapter does not apply to: (a) 7 (1) a sale conducted by order of a United States court under Title 11, United States Code; 8 9 (2) a sale conducted by an employee of the United States, this state, or a political subdivision of this state in the 10 11 course and scope of employment; 12 (3) a sale conducted by a charitable, religious, or 13 civic organization, including an organization having a tax exempt status under Section 501(c), Internal Revenue Code of 1986, or 14 organized as a nonprofit entity, if the person organizing, 15 16 arranging, or conducting the auction receives no compensation; (4) a sale conducted by any person of the person's 17 property if the person is not engaged in the business of selling 18 property at auction on a recurring basis; 19 (5) a foreclosure sale of real property personally 20 21 conducted by a trustee under a deed of trust; 22 a foreclosure sale of personal property personally (6) 23 conducted by: 24 (A) a person who holds a security interest in the
