- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 62.106(a), Government Code, is amended
- 6 to read as follows:
- 7 (a) A person qualified to serve as a petit juror may
- 8 establish an exemption from jury service if the person:
- 9 (1) is over 70 years of age;
- 10 (2) has legal custody of a child younger than 12 years
- 11 of age and the person's service on the jury requires leaving the
- 12 child without adequate supervision;
- 13 (3) is a student of a public or private secondary
- 14 school;
- 15 (4) is a person enrolled and in actual attendance at an
- 16 institution of higher education;
- 17 (5) is an officer or an employee of the senate, the
- 18 house of representatives, or any department, commission, board,
- 19 office, or other agency in the legislative branch of state
- 20 government;
- 21 (6) is summoned for service in a county with a
- 22 population of at least 200,000, unless that county uses a jury plan
- 23 under Section 62.011 and the period authorized under Section
- 24 62.011(b)(5) exceeds two years, and the person has served as a petit

- 1 juror in the county during the 24-month period preceding the date
- 2 the person is to appear for jury service;
- 3 (7) is the primary caretaker of a person who is an
- 4 invalid unable to care for himself or herself;
- 5 (8) except as provided by Subsection (b), is summoned
- 6 for service in a county with a population of at least 250,000 and
- 7 the person has served as a petit juror in the county during the
- 8 three-year period preceding the date the person is to appear for
- 9 jury service; [or]
- 10 (9) is a member of the United States military forces
- 11 serving on active duty and deployed to a location away from the
- 12 person's home station and out of the person's county of residence;
- 13 (10) is a firefighter, including a fire chief, who is
- 14 a permanent, paid employee of the fire department of a municipality
- 15 or county or of a special district or authority that provides
- 16 <u>firefighting services; or</u>
- 17 (11) is a police officer, including a police chief,
- 18 who is a permanent, paid employee of the police department of a
- 19 municipality or county.
- SECTION 2. This Act applies only to a person summoned to
- 21 appear for jury service who is required to appear on or after the
- 22 effective date of this Act. A person summoned to appear for jury
- 23 service who is required to appear before the effective date of this
- 24 Act is governed by the law in effect immediately before the
- 25 effective date of this Act, and the former law is continued in
- 26 effect for that purpose.
- 27 SECTION 3. This Act takes effect September 1, 2015.
