- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. The heading to Chapter 823, Health and Safety
- 6 Code, is amended to read as follows:
- 7 CHAPTER 823. ANIMAL SHELTERS AND RELEASING AGENCIES
- 8 SECTION 2. Chapter 823, Health and Safety Code, is amended
- 9 by designating Sections 823.001 through 823.009 as Subchapter A and
- 10 adding a subchapter heading to read as follows:
- 11 SUBCHAPTER A. GENERAL PROVISIONS; ANIMAL SHELTERS
- 12 SECTION 3. Section 823.001, Health and Safety Code, is
- 13 amended by adding Subdivision (5) to read as follows:
- 14 (5) "Releasing agency" has the meaning assigned by
- 15 Section 828.001.

- 16 SECTION 4. Chapter 823, Health and Safety Code, is amended
- 17 by adding Subchapter B to read as follows:
- SUBCHAPTER B. TREATMENT AND CARE OF ANIMALS
- 19 Sec. 823.051. ANIMAL TREATMENT PROTOCOL. At the time an
- 20 animal shelter or releasing agency takes possession of an animal,
- 21 an agent for the shelter or agency may administer a nonprescription
- 22 vaccine, nonprescription medicine, or medicine that is not a
- 23 controlled substance if:
- 24 (1) the medicine is necessary to prevent or control

- 1 communicable diseases or internal or external parasites; and
- 2 (2) the medicine is administered in accordance with a
- 3 protocol developed under Section 801.366, Occupations Code.
- 4 SECTION 5. Section 828.012(a), Health and Safety Code, is
- 5 amended to read as follows:
- 6 (a) Surgery or nonsurgical sterilization performed in
- 7 accordance with this chapter must <u>also</u> be performed <u>in accordance</u>
- 8 with Section 801.365 [by a veterinarian or a full-time student of an
- 9 accredited college of veterinary medicine as provided by Chapter
- 10 801], Occupations Code.
- 11 SECTION 6. Subchapter A, Chapter 801, Occupations Code, is
- 12 amended by amending Section 801.004 and adding Section 801.005 to
- 13 read as follows:
- 14 Sec. 801.004. APPLICATION OF CHAPTER. Except as provided
- 15 by Section 801.005, this [This] chapter does not apply to:
- 16 (1) the treatment or care of an animal in any manner by
- 17 the owner of the animal, an employee of the owner, or a designated
- 18 caretaker of the animal, unless the ownership, employment, or
- 19 designation is established with the intent to violate this chapter;
- 20 (2) a person who performs an act prescribed by the
- 21 board as an accepted livestock management practice, including:
- (A) castrating a male animal raised for human
- 23 consumption;
- 24 (B) docking or earmarking an animal raised for
- 25 human consumption;
- 26 (C) dehorning cattle;
- (D) aiding in the nonsurgical birth process of a

- 1 large animal, as defined by board rule;
- 2 (E) treating an animal for disease prevention
- 3 with a nonprescription medicine or vaccine;
- 4 (F) branding or identifying an animal in any
- 5 manner;
- 6 (G) artificially inseminating an animal,
- 7 including training, inseminating, and compensating for services
- 8 related to artificial insemination; and
- 9 (H) shoeing a horse;
- 10 (3) the performance of a cosmetic or production
- 11 technique to reduce injury in poultry intended for human
- 12 consumption;
- 13 (4) the performance of a duty by a veterinarian's
- 14 employee if:
- 15 (A) the duty involves food production animals;
- 16 (B) the duty does not involve diagnosis,
- 17 prescription, or surgery;
- 18 (C) the employee is under the direction and
- 19 general supervision of the veterinarian; and
- 20 (D) the veterinarian is responsible for the
- 21 employee's performance;
- 22 (5) the performance of an act by a person who is a
- 23 full-time student of an accredited college of veterinary medicine
- 24 if the act is performed under the direct supervision of a
- 25 veterinarian;
- 26 (6) an animal shelter employee who performs euthanasia
- 27 in the course and scope of the person's employment if the person has

- 1 successfully completed training in accordance with Chapter 829,
- 2 Health and Safety Code;
- 3 (7) a person who is engaged in a recognized
- 4 state-federal cooperative disease eradication or control program
- 5 or an external parasite control program while the person is
- 6 performing official duties required by the program;
- 7 (8) a person who, without expectation of compensation,
- 8 provides emergency care in an emergency or disaster; or
- 9 (9) a consultation given to a veterinarian in this
- 10 state by a person who:
- 11 (A) resides in another state; and
- 12 (B) is lawfully qualified to practice veterinary
- 13 medicine under the laws of that state.
- 14 Sec. 801.005. TREATMENT OF ANIMAL IN ANIMAL SHELTER OR
- 15 RELEASING AGENCY. This chapter applies to a veterinarian when
- 16 treating an animal on behalf of or in:
- 17 (1) an animal shelter, as defined by Section 823.001,
- 18 Health and Safety Code; or
- 19 (2) a releasing agency, as defined by Section 828.001,
- 20 Health and Safety Code.
- 21 SECTION 7. Subchapter H, Chapter 801, Occupations Code, is
- 22 amended by adding Sections 801.365 and 801.366 to read as follows:
- 23 <u>Sec. 801.365. STERILIZATION. Surgery or nonsurgical</u>
- 24 sterilization performed in accordance with Chapter 828, Health and
- 25 Safety Code, must be performed by a veterinarian or a person who is
- 26 <u>a full-time student of an accredited college of veterinary</u>
- 27 <u>medicine.</u>

- Sec. 801.366. ANIMAL SHELTER OR RELEASING AGENCY TREATMENT 1 PROTOCOL. (a) A veterinarian who makes medically appropriate and 2 timely visits to an animal shelter or releasing agency may, in 3 consultation with the animal shelter or releasing agency, develop a 4 5 written animal treatment protocol to authorize an agent of the animal shelter or releasing agency to administer a nonprescription 6 7 vaccine, nonprescription medicine, or medicine that is not a controlled substance as necessary to prevent or control 8 9 communicable diseases or internal or external parasites.
- 10 (b) A written animal treatment protocol developed under
 11 Subsection (a) must meet the minimum acceptable standard of care
 12 for the administration of a nonprescription vaccine,
 13 nonprescription medicine, or medicine that is not a controlled
 14 substance used to prevent or control communicable diseases or
 15 internal or external parasites.
- 16 <u>(c) A veterinarian who develops a written animal treatment</u> 17 protocol under this section does not violate Section 801.351.
- 18 (d) In this section:
- (1) "Animal shelter" has the meaning assigned by
- 20 Section 823.001, Health and Safety Code; and
- 21 (2) "Releasing agency" has the meaning assigned by
- 22 <u>Section 828.001, Health and Safety Code.</u>
- 23 SECTION 8. This Act takes effect September 1, 2015.
