H.B. No. 1373

A BILL TO BE ENTITLED

AN ACT

relating to the assignment of a public school student to an inexperienced or uncertified teacher.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Section 7.056(e), Education Code, is amended to read as follows:

(e) Except as provided by Subsection (f), a school campus or district may not receive an exemption or waiver under this section from:

(1) a prohibition on conduct that constitutes a criminal offense;

(2) a requirement imposed by federal law or rule, including a requirement for special education or bilingual education programs; or

(3) a requirement, restriction, or prohibition relating to:

(A) essential knowledge or skills under Section 28.002 or high school graduation requirements under Section 28.025;

(B) public school accountability as provided by Subchapters B, C, D, E, and J, Chapter 39;

(C) extracurricular activities under Section 33.081 or participation in a University Interscholastic League area, regional, or state competition under Section 33.0812;

(D) health and safety under Chapter 38;

22 SECTION 2. Subchapter B, Chapter 28, Education Code, is

23 amended by adding Section 28.0215 to read as follows:

24 Sec. 28.0215. REQUIREMENTS FOR ASSIGNMENT OF STUDENTS TO

25 TEACHERS. (a) This section applies only to a school district with

26 an enrollment of 5,000 or more students.

27 (b) A student in first through grade six who attends an

elementary school may not be assigned for two consecutive school years to a teacher who:

(1) has less than one year of teaching experience; or
(2) does not hold the appropriate certificate required under Section 21.003.

(c) The requirement imposed by Subsection (b) does not apply if the student's parent or other person standing in parental relation to the student and a school counselor or school administrator agree otherwise regarding assignment of the student to a teacher.

(d) Subsection (b) does not apply to the first year a student transfers into a school district.

(e) Subsection (b) does not apply to teachers teaching outside of the foundation curriculum stated in Section 28.002(1).

(f) The commissioner may grant a waiver from the requirements of this section to a school district if the commissioner finds that extreme circumstances in the district warrant the waiver. The commissioner may adopt rules as necessary to implement this section.

SECTION 3. This Act applies beginning with the 2015-2016 school year.

SECTION 4. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2015.
