- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 4 SECTION 1. Section 258.001, Occupations Code, is amended to

- 6 Sec. 258.001. [IMPERMISSIBLE] DELEGATIONS. (a) A dentist
- 7 may not delegate:
- 8 (1) an act to an individual who, by board order, is
- 9 prohibited from performing the act;

- 17 (C) any other act the delegation of which is

- 21 (A) comprehensive examination or diagnosis and

- 23 (B) a surgical or cutting procedure on hard or

26	(6) administers intraoral block or infiltration

- 4 (c) A dental hygienist may not establish an independent

- 6 SECTION 3. (a) The State Board of Dental Examiners, not
- 7 later than January 1, 2016, shall:
- 8 (1) prescribe by rule the requirements for a course to
- 9 train dental hygienists to administer local anesthetic agents; and
- 10 (2) develop a procedure for the approval of courses
- 11 described by Subdivision (1) of this subsection.
- 12 (b) A rule adopted under Subsection (a) of this section must
- 13 require that a course is:
- 14 (1) accredited by the Commission on Dental
- 15 Accreditation of the American Dental Association; and
- 16 (2) offered in a classroom setting at an educational
- 17 institution.
- 18 SECTION 4. This Act takes effect September 1, 2015.
