A BILL TO BE ENTITLED AN ACT

1-19 relating to the administration of epinephrine by pharmacists. 1-20 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 1-21

SECTION 1. Subchapter B, Chapter 562, Occupations Code, is amended by adding Section 562.057 to read as follows: 1-22 1-23

Sec. 562.057. ADMINISTRATION OF EPINEPHRINE. (a) pharmacist may administer epinephrine through an auto-injector 1-24 1-25 device in accordance with this section.

(b) The board shall adopt rules designed to protect the public health and safety to implement this section. The rules must provide that a pharmacist may administer epinephrine through an 1-26 1-27 1-28 1-29 auto-injector device to a patient in an emergency situation.

1-30 (c) A pharmacist may maintain, administer, and dispose of 1-31 epinephrine auto-injector devices only in accordance with rules adopted by the board under this section. 1-32

(d) A pharmacist who administers epinephrine through an auto-injector device to a patient shall report the use to the 1-33 1-34 patient's primary care physician, as identified by the patient, if 1-35 1-36

the patient has a primary care physician. (e) A pharmacist who in good faith administers epinephrine through an auto-injector device in accordance with the requirements 1-37 1-38 1-39 of this section is not liable for civil damages for an act performed in the administration unless the act is wilfully or wantonly 1-40 negligent. A pharmacist may not receive remuneration for the administration of epinephrine through an auto-injector device but may seek reimbursement for the cost of the epinephrine 1-41 1-42 1-43 auto-injector device. 1-44

(f) The administration of epinephrine through an auto-injector device to a patient in accordance with the requirements of this section does not constitute the unlawful practice of any health care profession. 1-45 1-46 1-47 1-48

SECTION 2. Before January 1, pharmacists 1-49 2016, mav administer epinephrine through an auto-injector device to the extent allowed under the law that exists before September 1, 2015. 1-50 1-51 1-52

SECTION 3. (a) Except as provided by Subsection (b) of this section, this Act takes effect September 1, 2015. 1-53 1-54 (b) Section 562.057, Occupations Code, as added by this Act,
