- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 7.060, Education Code, is amended by
- 6 adding Subsection (a-1) to read as follows:
- 7 (a-1) The review conducted under Subsection (a) must
- 8 include a comparison of the reports and paperwork required by state
- 9 <u>law and the reports and paperwork required by federal law. The</u>
- 10 commissioner shall eliminate any reports or paperwork required by
- 11 state law that duplicate the content of reports or paperwork also
- 12 <u>required by federal law.</u>
- SECTION 2. Section 11.201(d), Education Code, is amended to
- 14 read as follows:
- 15 (d) The duties of the superintendent include:
- 16 (1) assuming administrative responsibility and
- 17 leadership for the planning, organization, operation, supervision,
- 18 and evaluation of the education programs, services, and facilities
- 19 of the district and for the annual performance appraisal of the
- 20 district's staff;
- 21 (2) except as provided by Section 11.202, assuming
- 22 administrative authority and responsibility for the assignment,
- 23 supervision, and evaluation of all personnel of the district other
- 24 than the superintendent;

- 1 (3) overseeing compliance with the standards for
- 2 school facilities established by the commissioner under Section
- 3 46.008;
- 4 (4) initiating the termination or suspension of an
- 5 employee or the nonrenewal of an employee's term contract;
- 6 (5) managing the day-to-day operations of the district
- 7 as its administrative manager, including implementing and
- 8 monitoring plans, procedures, programs, and systems to achieve
- 9 clearly defined and desired results in major areas of district
- 10 operations;
- 11 (6) preparing and submitting to the board of trustees
- 12 a proposed budget as provided by Section 44.002 and rules adopted
- 13 under that section, and administering the budget;
- 14 (7) preparing recommendations for policies to be
- 15 adopted by the board of trustees and overseeing the implementation
- 16 of adopted policies;
- 17 (8) developing or causing to be developed appropriate
- 18 administrative regulations to implement policies established by
- 19 the board of trustees;
- 20 (9) providing leadership for the attainment and, if
- 21 necessary, improvement of student performance in the district based
- 22 on the indicators adopted under Sections 39.053 and 39.301 and
- 23 other indicators adopted by the commissioner or the district's
- 24 board of trustees;
- 25 (10) organizing the district's central
- 26 administration;
- 27 (11) consulting with the district-level committee as

- 1 required under Section 11.252(f);
- 2 (12) ensuring:
- 3 (A) adoption of a student code of conduct as
- 4 required under Section 37.001 and enforcement of that code of
- 5 conduct; and
- 6 (B) adoption and enforcement of other student
- 7 disciplinary rules and procedures as necessary;
- 8 (13) submitting reports as required by state or
- 9 federal law, rule, or regulation, and ensuring that a copy of any
- 10 report required by federal law, rule, or regulation is also
- 11 delivered to the agency;
- 12 (14) providing joint leadership with the board of
- 13 trustees to ensure that the responsibilities of the board and
- 14 superintendent team are carried out; and
- 15 (15) performing any other duties assigned by action of
- 16 the board of trustees.
- 17 SECTION 3. This Act takes effect immediately if it receives
- 18 a vote of two-thirds of all the members elected to each house, as
- 19 provided by Section 39, Article III, Texas Constitution. If this
- 20 Act does not receive the vote necessary for immediate effect, this
- 21 Act takes effect September 1, 2015.
