A BILL TO BE ENTITLED AN ACT

relating to building energy efficiency performance standards. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 1-22 1-23 1-24

SECTION 1. Section 388.003, Health and Safety Code, is amended by amending Subsections (a), (b), (b-2), (b-3), (d), and (i) and adding Subsections (j) and (k) to read as follows: 1-25 1-26

(a) To achieve energy conservation in single-family residential construction, the energy efficiency chapter of the International Residential Code, as it existed on May 1, 2001, is 1-27 1-28 1-29 adopted as the energy code in this state for single-family 1-30 residential construction. On September 1, 2016, the energy efficiency chapter of the International Residential Code, as it existed on May 1, 2015, is adopted as the energy code in this state for single-family residential construction. On or after September 1-31 1-32 1-33 1-34 2021, the State Energy Conservation Office may adopt and 1-35 1, substitute for that energy code the latest published edition of the energy efficiency chapter of the International Residential Code, based on written findings on the stringency of the chapter submitted by the laboratory under Subsection (b-3). The office: 1-36 1-37 1-38 1-39 (1) may not adopt an edition under this subsection 1-40 1-41

more often than once every six years; and (2) by rule shall establish an effective date for an adopted edition that is not earlier than nine months after the date 1-42 1-43 of adoption. 1-44

(b) To 1-45 achieve energy conservation in all other residential, commercial, and industrial construction, the International Energy Conservation Code as it existed on May 1, 2001, is adopted as the energy code for use in this state for all 1-46 1-47 1-48 1-49 other residential, commercial, and industrial construction. The State Energy Conservation Office may adopt and substitute for that 1-50 energy code the latest published edition of the International Energy Conservation Code, based on written findings on the stringency of the edition submitted by the laboratory under 1-51 1-52 1-53 Subsection (b-3). The office by rule shall establish an effective 1-54 1-55 date for an adopted edition that is not earlier than nine months 1-56 after the date of adoption.
