18	(b) The plan described by Subsection (a) must:
19	(1) build on available experience and infrastructure
20	for reporting information and statistics concerning criminal

No. 1808 1 (3) contain input from stakeholders, including other 2 law enforcement agencies and law enforcement associations, 3 advocacy groups, and academic institutions; 4 (4) contain outreach strategies to educate the public 5 on the differences between a summary reporting system and an 6 incident-based reporting system; 7 (5) contain measures to track the progress and success 8 in this state of any incident-based reporting by state and local law enforcement agencies to the National Incident-Based Reporting 9 10 System of the Uniform Crime Reporting Program of the Federal Bureau of Investigation, the Texas Incident-Based Reporting System of the 11 12 department, or a successor program; and (6) examine the feasibility and desirability of 13 14 purchasing or developing for state and local law enforcement 15 agencies a records management system that meets the reporting requirements of the National Incident-Based Reporting System of the 16 17 Uniform Crime Reporting Program of the Federal Bureau of Investigation, the Texas Incident-Based Reporting System of the 18 19 department, or a successor program. SECTION 3. Section 1701.156, Occupations Code, is amended 25 26 by adding Subsection (c) to read as follows: 27 (c) The Department of Public Safety may use money

appropriated to the department from the account to award grants to
local law enforcement agencies for training on incident-based
reporting systems to be used for reporting information and
statistics concerning criminal offenses committed in this state.
The department shall adopt rules governing the award of grants by
the department under this subsection.

7 SECTION 4. Section 1701.157, Occupations Code, is amended 8 by adding Subsection (a-1) to read as follows:

9 <u>(a-1)</u> Subsection (a) does not apply to money appropriated to 10 the Department of Public Safety from the account for the purpose of 11 awarding grants to local law enforcement agencies for training on 12 incident-based reporting systems under Section 1701.156(c).

SECTION 5. Not later than January 1, 2016, the Department of Public Safety shall adopt rules as required by Section 1701.156(c), Occupations Code, as added by this Act.

16 SECTION 6. This Act takes effect immediately if it receives 17 a vote of two-thirds of all the members elected to each house, as 18 provided by Section 39, Article III, Texas Constitution. If this 19 Act does not receive the vote necessary for immediate effect, this 20 Act takes effect September 1, 2015.
