A BILL TO BE ENTITLED 1 AN ACT 2 relating to references to school in the Texas Family Code. 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 4 SECTION 1. Section 34.002(a), Family Code, is amended to 5 read as follows: 6 (a) A parent or both parents of a child may enter into an 7 authorization agreement with a relative of the child listed in Section 34.001 to authorize the relative to perform the following 8 9 acts in regard to the child: (1) to authorize medical, dental, psychological, or 10 11 surgical treatment and immunization of the child, including 12 executing any consents or authorizations for the release of information as required by law relating to the treatment or 13 14 immunization; (2) to obtain and maintain health insurance coverage 15 16 for the child and automobile insurance coverage for the child, if 17 appropriate; 18 (3) to enroll the child in a day-care program or preschool or in a public or private elementary [primary] or 19 20 secondary school; 21 (4) to authorize the child to participate in age-appropriate extracurricular, civic, social, or recreational 22 23 activities, including athletic activities; 24 (5) to authorize the child to obtain a learner's

1 permit, driver's license, or state-issued identification card;

(6) to authorize employment of the child; and

3 (7) to apply for and receive public benefits on behalf4 of the child.

5 SECTION 2. Section 101.028, Family Code, is amended to read 6 as follows:

Sec. 101.028. SCHOOL. "School" means <u>an elementary</u> [a <u>primary</u>] or secondary school in which a child is enrolled or, if the child is not enrolled in <u>an elementary</u> [a primary] or secondary school, the public school district in which the child primarily resides. <u>For purposes of this section, a reference to elementary</u> school includes prekindergarten.

13 SECTION 3. Section 153.3101, Family Code, is amended to 14 read as follows:

Sec. 153.3101. REFERENCE TO "SCHOOL" IN STANDARD POSSESSION ORDER. In a standard possession order, "school" means the <u>elementary</u> [primary] or secondary school in which the child is enrolled or, if the child is not enrolled in <u>an elementary</u> [a <u>primary</u>] or secondary school, the public school district in which the child primarily resides.

21 SECTION 4. Section 261.105(d), Family Code, is amended to 22 read as follows:

(d) If the department initiates an investigation and determines that the abuse or neglect does not involve a person responsible for the child's care, custody, or welfare, the department shall refer the report to a law enforcement agency for further investigation. If the department determines that the abuse

or neglect involves an employee of a public <u>elementary</u> [primary] or secondary school, and that the child is a student at the school, the department shall orally notify the superintendent of the school district in which the employee is employed about the investigation. SECTION 5. The changes in law made by this Act are
