1 AN ACT

- 2 relating to the transfer of certain state property from the Texas
- 3 Department of Transportation to the University of Houston.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. (a) Not later than December 31, 2015, the Texas
- 6 Department of Transportation shall donate and transfer to the
- 7 University of Houston the real property described by Subsection (e)
- 8 of this section.
- 9 (b) The University of Houston may use the property
- 10 transferred under this Act only for a purpose that benefits the
- 11 public interest of the state. If the University of Houston uses the
- 12 property for any purpose other than a purpose described by this
- 13 subsection, ownership of the property automatically reverts to the
- 14 Texas Department of Transportation.
- 15 (c) The Texas Department of Transportation shall transfer
- 16 the property by an appropriate instrument of transfer. The
- 17 instrument of transfer must:
- 18 (1) provide that:
- 19 (A) the University of Houston may use the
- 20 property only for a purpose that benefits the public interest of the
- 21 state; and
- (B) ownership of the property will automatically
- 23 revert to the Texas Department of Transportation if the University
- 24 of Houston uses the property for any purpose other than a purpose

- 1 described by Paragraph (A) of this subdivision; and
- 2 (2) describe the property to be transferred by metes
- 3 and bounds.
- 4 (d) The Texas Department of Transportation shall retain
- 5 custody of the instrument of transfer after the instrument of
- 6 transfer is filed in the real property records of Fort Bend County.
- 7 (e) The real property referred to in this section consists
- 8 of the following three tracts of land:
- 9 (1) Being a tract of land containing 5.000 acres
- 10 (217,800 square feet), located in the Alexander Hodges Survey,
- 11 Abstract-32, in Fort Bend County, Texas; being a portion of a called
- 12 1093.65 acre tract recorded in the name of the State of Texas, State
- 13 Department of Highways and Public Transportation in Volume 2329,
- 14 Page 50 of the Fort Bend County Deed Records, and being all of a call
- 15 5.000 acre tract recorded as Tract 5 Part 3 of the State of Texas
- 16 Department of Transportation Tract 5 Partition Plat, a plat of
- 17 record in Slide Numbers 1655B and 1656A of the Plat Records of Fort
- 18 Bend County; said 5.000 acre tract being more particularly
- 19 described by metes and bounds as follows (all bearings referenced
- 20 to said Tract 5 partition plat):
- Beginning at a TxDOT disk found at the northwest corner of a
- 22 said 5.000 acre tract, and being on the southeasterly Right-Of-Way
- 23 (R.O.W.) line of U.S. Highway 59 (width varies), from which a TxDOT
- 24 disk found for an angle point in said southeasterly R.O.W. line
- 25 bears South 52 degrees 29 minutes 36 seconds West, a distance of
- 26 453.80 feet;
- Thence, with the lines common to said 5.000 acre tract and the

- 1 southeasterly R.O.W. line of said U.S. Highway 59, the following
- 2 two (2) courses:
- 3 1. North 52 degrees 29 minutes 44 seconds East, a distance
- 4 of 400.00 feet to a TxDOT disk found for an angle point;
- 5 2. North 76 degrees 03 minutes 27 seconds East, a distance
- 6 of 339.25 feet to a TxDOT disk found at the northeast corner of said
- 7 5.000 acres and the northwest corner of a call 8.000 acre tract
- 8 recorded as Tract 5, Part 4 of said Tract 5 partition plat, for the
- 9 northeast corner of the herein described tract;
- Thence, with the line common to said 5.000 acre and said 8.000
- 11 acre tracts, South 04 degrees 10 minutes 00 seconds East, a distance
- 12 of 436.38 feet to a TxDOT disk found at the southeast corner of said
- 13 5.000 acre tract and being a northeasterly corner of The Board of
- 14 Regents of the University of Houston System Tract 5, Part 2 (U of H)
- 15 recorded in Fort Bend County Clerk's File Number 98103479, for the
- 16 southeast corner of the herein described tract;
- 17 Thence, with the lines common to said U of H tract and said
- 18 5.000 acre tract, the following two (2) courses:
- 1. South 85 degrees 50 minutes 00 seconds West, a distance
- 20 of 563.90 feet to a TxDOT disk found at the southwest corner of said
- 21 5.000 acre and the herein described tract;
- 22 2. North 37 degrees 31 minutes 00 seconds West, a distance
- 23 of 190.28 feet to the Point of Beginning and containing 5.000 acres
- 24 (217,800 square feet) of land;
- 25 (2) Being a tract of land containing 3.194 acres
- 26 (139,131 square feet), located in the Alexander Hodges Survey,
- 27 Abstract-32, in Fort Bend County, Texas; being a portion of a call

- 16 southeasterly R.O.W. line of U.S. Highway 59, North 52 degrees 29
- 17 minutes 44 seconds East, a distance of 400.00 feet to a TxDOT disk
- 18 found for the southwest corner and Point of Beginning of the herein
- 19 described tract;
- Thence, through and across said 105.505 acre tract and with
- 21 the proposed south R.O.W. line of said U.S. Highway 59, and the
- 22 proposed west R.O.W. line of University Boulevard, the following
- 23 five (5) courses:
- 1. North 52 degrees 29 minutes 44 seconds East, a distance
- of 409.89 feet to a 5/8-inch iron rod with a Miller Survey Group
- 26 (MSG) cap set for an angle point;

- 19 the north lines of said 8.000 acre and 5.000 acre tracts, the
- 20 following three (3) courses:
- 1. North 49 degrees 10 minutes 00 seconds West, a distance
- of 35.51 feet to a 5/8 inch iron Rod with a MSG cap set for an angle
- 23 point;
- 2. South 86 degrees 05 minutes 07 seconds West, a distance
- 25 of 374.89 feet to a TxDOT disk found for the northwest corner of
- 26 said 8.000 acre tract and the northeast corner of said 5.000 acre
- 27 tract;

- 6 Abstract-32, in Fort Bend County, Texas; being all of a call 8.000
- 7 acre tract recorded in the name of the State of Texas, State
- 8 Department of Highways and Public Transportation in Volume 1821,
- 9 Page 993 of the Fort Bend County Deed Records, and platted as Tract
- 10 5 Part 4 of the State of Texas Department of Transportation Tract 5
- 11 Partition Plat, a plat of record in Slide Numbers 1655B and 1656A of
- 12 the Plat Records of Fort Bend County; said 8.000 acre tract being
- 13 more particularly described by metes and bounds as follows (all
- 14 bearings referenced to said Tract 5 partition plat):
- 15 Commencing at a TxDOT disk found at the northwest corner of a
- 16 call 5.000 acre tract recorded as Tract 5, Part 3 of said Tract 5
- 17 partition plat, and being on the southeasterly Right-Of-Way
- 18 (R.O.W.) line of U.S. Highway 59 (width varies), from which a TxDOT
- 19 disk found for an angle point in said southeasterly R.O.W. line

- 9 R.O.W. line of University Boulevard (width varies per said Tract 5
- 10 partition plat), for the northeast corner of said 8.000 acre and the
- 11 herein described tract;
- 12 Thence, with the west R.O.W. line of said University
- 13 Boulevard, and the east line of said 8.000 acre tract, South 04
- 14 degrees 10 minutes 00 seconds East, a distance of 846.11 feet to an
- 15 "X" cut in concrete set at the southeast corner of said 8.000 acre
- 16 tract and being an easterly northeast corner of The Board of Regents
- 17 of the University of Houston System Tract 5, Part 2 (U of H)
- 18 recorded in Fort Bend County Clerk's File Number 98103479, for the
- 19 southeast corner of the herein described tract;
- Thence, with the lines common to said U of H tract and said
- 21 8.000 acre tract, South 85 degrees 50 minutes 00 seconds West, a
- 22 distance of 400.00 feet to an "X" cut in concrete set at the
- 23 southwest corner of said 8.000 acre and the herein described tract;
- Thence, with the west line of said 8.000 acre tract, a
- 25 northeast line of said U of H tract and the east line of said 5.000
- 26 acre tract, North 04 degrees 10 minutes 00 seconds West, at a
- 27 distance of 436.49 feet pass a TxDOT disk found at the southeast

- 1 corner of said 5.000 acre tract and continue in all a total distance
- 2 of 872.87 feet to the Point of Beginning and containing 8.000 acres
- 3 (348,480 square feet) of land.
- SECTION 2. This Act takes effect September 1, 2015.
