## A BILL TO BE ENTITLED

1 AN ACT

- 2 relating to a volume-based exemption from reporting requirements
- 3 for certain accidental discharges or spills from wastewater
- 4 facilities.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Section 26.039, Water Code, is amended by
- 7 amending Subsections (b) and (e) and adding Subsections (g) and (h)
- 8 to read as follows:
- 9 (b) Except as provided by Subsection (g), whenever
- 10 [Whenever] an accidental discharge or spill occurs at or from any
- 11 activity or facility which causes or may cause pollution, the
- 12 individual operating, in charge of, or responsible for the activity
- 13 or facility shall notify the commission as soon as possible and not
- 14 later than 24 hours after the occurrence. The individual's notice
- 15 to the commission must include the location, volume, and content of
- 16 the discharge or spill.
- (e) Except as provided by Subsection (g), if  $[\frac{1}{1}]$  an
- 18 accidental discharge or spill described by Subsection (b) from a
- 19 wastewater treatment or collection facility owned or operated by a
- 20 local government may adversely affect a public or private source of
- 21 drinking water, the individual shall also notify appropriate local
- 22 government officials and local media.
- 23 (g) The individual is not required to notify the commission
- 24 under Subsection (b) or officials or media under Subsection (e) of a

- 1 single accidental discharge or spill that:
- 2 (1) occurs at a wastewater treatment or collection
- 3 facility owned or operated by a local government;
- 4 (2) is 1,000 gallons or less;
- 5 (3) is not associated with another simultaneous
- 6 accidental discharge or spill;
- 7 (4) is controlled or removed before the accidental
- 8 discharge or spill:
- 9 (A) enters water in the state; or
- 10 (B) adversely affects a public or private source
- 11 of drinking water; and
- 12 (5) will not endanger human health or safety or the
- 13 environment.
- 14 (h) The individual shall submit to the commission at least
- 15 once each month a summary of accidental discharges and spills
- 16 described by Subsection (g) that occurred during the preceding
- 17 month. The commission by rule shall establish procedures for
- 18 formatting and submitting a summary, including requirements that a
- 19 summary include the location, volume, and content of each
- 20 accidental discharge or spill.
- 21 SECTION 2. (a) Not later than December 1, 2015, the Texas
- 22 Commission on Environmental Quality shall adopt rules necessary to
- 23 implement Section 26.039, Water Code, as amended by this Act.
- 24 (b) The change in law made by this Act applies only to an
- 25 offense committed on or after the effective date of a rule adopted
- 26 by the Texas Commission on Environmental Quality under this
- 27 section. For purposes of this section, an offense was committed

- 1 before the effective date of a rule adopted by the Texas Commission
- 2 on Environmental Quality under this section if any element of the
- 3 offense occurred before that date.
- 4 (c) An offense committed before the effective date of a rule
- 5 adopted by the Texas Commission on Environmental Quality under this
- 6 section is governed by the law in effect on the date the offense was
- 7 committed, and the former law is continued in effect for that
- 8 purpose.
- 9 SECTION 3. This Act takes effect September 1, 2015.
