No. 2054 1 institution; or 2 (B) with the intent to establish, maintain, or 3 participate in a combination or in the profits of a combination; 4 (6) the person: 5 (A) while incarcerated for an offense under this section or Section 19.02, murders another; or 6 7 while serving a sentence of life imprisonment (B) 8 or a term of 99 years for an offense under Section 20.04, 22.021, or 29.03, murders another; 9 10 (7) the person murders more than one person: 11 (A) during the same criminal transaction; or 12 (B) during different criminal transactions but the murders are committed pursuant to the same scheme or course of 13 14 conduct; 15 (8) the person murders an individual under 10 years of 16 age; or 17 (9) the person murders another person in retaliation for or on account of the service or status of the other person as a 18 19 judge or justice of the supreme court, the court of criminal appeals, a court of appeals, a district court, a criminal district 20 court, a constitutional county court, a statutory county court, a 21 justice court, or a municipal court. 22 SECTION 2. 2 (b-1) An offense under [this section is a felony of the 3 first degree if:

[(1) the applicable conduct constitutes an offense under] Subsection (a)(5), (6), (7), or (8) is a felony of the first degree punishable by imprisonment in the Texas Department of <u>Criminal Justice for life or for any term of not more than 99 years</u> or less than 25 years, regardless of whether the actor knows the age of the child at the time the actor commits the offense.

10 (b-2) Notwithstanding Subsection (b) or (b-1), an offense 11 under this section is a felony of the first degree punishable by 12 imprisonment in the Texas Department of Criminal Justice for life 13 without parole if [; or

14 [(2)] the commission of the offense results in the 15 death of the person who is trafficked.

SECTION 3. Section 2(a), Article 38.37, Code of Criminal Procedure, is amended to read as follows:

SECTION 4. The change in law made by this Act applies only 13 to an offense committed on or after the effective date of this Act. 14 15 An offense committed before the effective date of this Act is governed by the law in effect on the date the offense was committed, 16 and the former law is continued in effect for that purpose. 17 For purposes of this section, an offense was committed before the 18 effective date of this Act if any element of the offense occurred 19 20 before that date. SECTION 5. This Act takes effect September 1, 2015. 21
