- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Section 181.082, Utilities Code, is amended to
- 7 read as follows:
- 8 Sec. 181.082. AUTHORITY TO INSTALL FACILITY IN RELATION TO
- 9 PUBLIC PROPERTY. Subject to Section 181.0821, a [A] telephone or
- 10 telegraph corporation may install a facility of the corporation
- 11 along, on, or across a public road, a public street, or public water
- 12 in a manner that does not inconvenience the public in the use of the
- 13 road, street, or water.
- 14 SECTION 2. Subchapter E, Chapter 181, Utilities Code, is
- 15 amended by adding Sections 181.0821 and 181.0822 to read as
- 16 follows:
- Sec. 181.0821. NOTICE TO STATE OR COUNTY. (a) A person
- 18 proposing to install a facility under Section 181.082 in the
- 19 right-of-way of a state highway or a county road shall give notice
- 20 of the proposed installation to:
- 21 (1) the Texas Department of Transportation if the
- 22 proposed installation relates to a state highway; or
- 23 (2) the commissioners court of the county if the
- 24 proposed installation relates to a county road.

- 1 (b) On receipt of the notice, the Texas Department of
- 2 Transportation or commissioners court may designate the location in
- 3 the right-of-way where the person may install the facility.
- 4 Sec. 181.0822. RELOCATION OF FACILITY TO ALLOW ROAD OR
- 5 DITCH IMPROVEMENT. (a) The Texas Department of Transportation or
- 6 the commissioners court of a county may require a telephone or
- 7 telegraph corporation to relocate a facility of the corporation, at
- 8 the corporation's expense, to allow the:
- 9 (1) widening of a right-of-way;
- 10 (2) changing of a traffic lane;
- 11 (3) improving of a road bed; or
- 12 (4) improving of a drainage ditch located on a
- 13 right-of-way.
- 14 (b) To require relocation under Subsection (a), the Texas
- 15 Department of Transportation or the commissioners court, as
- 16 appropriate, must notify the telephone or telegraph corporation not
- 17 later than the 30th day before the date relocation is required. The
- 18 notice must identify the facility to be relocated and indicate the
- 19 location on the new right-of-way where the telephone or telegraph
- 20 corporation may place the facility.
- 21 (c) This section does not apply to a facility located in a
- 22 <u>municipality.</u>
- 23 SECTION 3. This Act takes effect September 1, 2015.
