- 8 5190.14, Vernon's Texas Civil Statutes), are amended to read as

- 10 (4) "Event" means a Super Bowl, a National Collegiate

- 12 Basketball Association All-Star Game, the X Games, the National
- 13 Hockey League All-Star Game, the Major League Baseball All-Star
- 14 Game, a game of the National Collegiate Athletic Association Bowl

- 16 Athletic Association Division I Football Bowl Subdivision
- 17 postseason playoff or championship game, a World Cup Soccer game,
- 18 the World Games, a Professional Rodeo Cowboys Association finals
- 19 event, a national collegiate championship of an amateur sport
- 20 sanctioned by the national governing body of the sport that is
- 21 recognized by the United States Olympic Committee, an Olympic
- 22 activity, including a Junior or Senior activity, training program,
