Article 15.08, Code of Criminal Procedure, is 5 amended to read as follows: 6 Art. 15.08. WARRANT MAY BE FORWARDED. A warrant of arrest 7 may be forwarded by any method that ensures the transmission of a 8 9 duplicate of the original warrant, including secure facsimile transmission or other secure electronic means [or a telegraph 10 11 transmission from any telegraph office to another in this State]. 12 If issued by any magistrate named in Article 15.06, the peace officer receiving the same shall execute it without delay. If it be 13 14 issued by any other magistrate than is named in Article 15.06, the peace officer receiving the same shall proceed with it to the 15 16 nearest magistrate of the peace officer's county, who shall endorse thereon, in substance, these words: 17 18 "Let this warrant be executed in the county of . . . . . . . . . . . . . . . . which endorsement shall be dated and 19 signed officially by the magistrate making the same. 20 21 SECTION 2. Article 15.19(a), Code of Criminal Procedure, is 22 amended to read as follows:

(a) If the arrested person fails or refuses to give bail, as
