- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. Section 2151.051, Occupations Code, is amended
- 7 to read as follows:
- 8 Sec. 2151.051. GENERAL POWERS AND DUTIES. <u>Except as</u>
- 9 provided by Subchapter E, the [The] commissioner shall administer
- 10 and enforce this chapter.
- 11 SECTION 2. Chapter 2151, Occupations Code, is amended by
- 12 adding Subchapter E to read as follows:
- 13 <u>SUBCHAPTER E. CERTAIN INFLATABLE AMUSEMENT RIDES</u>
- Sec. 2151.201. APPLICABILITY. (a) This subchapter applies
- 15 only to a Class B amusement ride that:
- 16 (1) is mechanically inflated using a continuous
- 17 airflow device; and
- (2) provides a surface for bouncing and jumping or
- 19 <u>creates an enclosed space for the purpose of amusement.</u>
- 20 (b) The requirements for operation, liability insurance,
- 21 inspections, injury reports, and signage provided under Subchapter
- 22 C do not apply to a Class B amusement ride regulated under this
- 23 subchapter.
- Sec. 2151.202. REGULATORY AUTHORITY; RULES. (a)

- 1 Notwithstanding any other provision of this chapter, an amusement
- 2 ride to which this subchapter applies is regulated by the Texas
- 3 Department of Licensing and Regulation.
- 4 (b) The Texas Commission of Licensing and Regulation shall
- 5 adopt rules necessary to implement and enforce this subchapter and
- 6 to protect the public safety.
- 7 Sec. 2151.203. LICENSE REQUIRED. A person may not operate
- 8 in this state an amusement ride to which this subchapter applies
- 9 unless the person holds a license issued under this subchapter by
- 10 the Texas Department of Licensing and Regulation.
- 11 SECTION 3. (a) Not later than December 1, 2015, the Texas
- 12 Commission of Licensing and Regulation shall adopt the rules
- 13 necessary to implement Subchapter E, Chapter 2151, Occupations
- 14 Code, as added by this Act.
- 15 (b) Notwithstanding Subchapter E, Chapter 2151, Occupations
- 16 Code, as added by this Act, a person is not required to hold a
- 17 license to operate an amusement ride governed by that subchapter
- 18 until January 1, 2016.
- 19 SECTION 4. This Act takes effect September 1, 2015.
