- 4 SECTION 6. Section 2652.101(a), Insurance Code, is amended

- 8 under Section 2652.1511 payable to the department. The bond shall
- 9 obligate the principal and surety to pay for any pecuniary loss

- SECTION 7. Section 2652.151(a), Insurance Code, is amended

- 16 (a) A title insurance agent or direct operation shall
- 17 certify to the department, not later than the expiration date of the
- 18 title insurance agent's or direct operation's license, the name and
- 19 address of each individual employed and appointed under Section

- SECTION 8. Subchapter D, Chapter 2652, Insurance Code, is
- 23 amended by adding Section 2652.1511 to read as follows:
- Sec. 2652.1511. APPOINTMENT OF ESCROW OFFICER. (a) An
- 25 escrow officer may be employed and appointed by more than one title
- 26 insurance agent or direct operation.
- (b) Before an escrow officer may act in that capacity for a

- 2 agent or direct operation must appoint the escrow officer and file

- 16 <u>a surety bond or deposit required under Subchapter C.</u>
- 17 (d) The appointment of the escrow officer expires on the
- 18 revocation, termination, or nonrenewal of the escrow officer's
- 19 license or termination of the escrow officer's employment with the
- 20 title insurance agent or direct operation that made the
- 21 <u>appointment.</u>
- (e) Unless otherwise notified by the department, the escrow
- 23 officer may act as an escrow officer for the appointing title
- 24 insurance agent or direct operation after:
- 25 <u>(1) the second business day after the date the</u>
- 26 appointment is submitted to the department electronically; or
- 27 (2) the eighth business day after the date the

- 1 appointment is submitted to the department on a nonelectronic form.
- 2 SECTION 9. Section 2652.153, Insurance Code, is amended to
- 3 read as follows:
- 4 Sec. 2652.153. NOTICE OF TERMINATION. A title insurance
- 5 agent or direct operation that terminates the employment of a
- 6 licensed escrow officer shall:
- 7 (1) immediately notify the department in writing of
- 8 the termination and request cancellation of the appointment under
- 9 Section 2652.1511 [license]; and
- 10 (2) notify the escrow officer of the action by the
- 11 title insurance agent or direct operation.
- 12 SECTION 10. Section 2652.203, Insurance Code, is amended by
- 13 amending Subsections (a) and (d) and adding Subsection (e) to read
- 14 as follows:
- 15 (a) The department shall notify a license holder of a
- 16 disciplinary action or enforcement action against the license
- 17 holder not later than the 30th business day after the date the
- 18 department assigns a file number to the action, except that this
- 19 subsection does not apply to a file or action:
- 20 (1) that is the subject of a pending criminal
- 21 investigation or prosecution; or
- 22 (2) about which the [deputy commissioner of the title
- 23 division of the] department makes a good faith determination that
- 24 there is a credible suspicion that there are ongoing or continuing
- 25 acts of fraud by a person who is the subject of the action.
- 26 (d) The department may provide information about an
- 27 enforcement action, including a copy of a notice issued under this

- 2 which an escrow officer has, or proposes to obtain, an appointment
- 3 under Section 2652.1511 [employment].
- 4 (e) Except as prohibited by Chapter 552, Government Code, or
- 5 any other law, on the date an enforcement action against an escrow
- 6 officer becomes final, the department shall provide information
- 7 about the action, including a copy of a commissioner's order or
- 8 department warning issued under this section, to each title
- 9 insurance agent or direct operation for which the escrow officer
- 10 holds appointment under Section 2652.1511.
- 11 SECTION 11. Sections 2652.057(b) and 2652.152, Insurance
- 12 Code, are repealed.
- 13 SECTION 12. The changes in law made by this Act apply only
- 14 to the issuance or renewal of the license of an escrow officer on or
- 15 after January 1, 2016. The issuance or renewal of a license before
- 16 January 1, 2016, is governed by the law as it existed immediately
- 17 before the effective date of this Act, and that law is continued in
- 18 effect for that purpose.
- 19 SECTION 13. This Act takes effect September 1, 2015.
