11	implement a program designated as the human trafficking prevention
12	business partnership to engage participating corporations and
13	other private entities in voluntary efforts to prevent and combat
14	human trafficking.
15	(c) The secretary of state shall present a certificate of
16	recognition to a participating corporation or private entity to
17	recognize the corporation's or entity's contributions to the
18	efforts of federal, state, and local officials engaged in
19	combatting human trafficking and prosecuting human trafficking
20	<u>crimes.</u>
21	(d) A corporation or other private entity that participates
22	in the partnership shall:
23	(1) adopt a zero tolerance policy toward human

1	(2) take measures to ensure that the corporation's or
2	entity's employees comply with the policy adopted under Subdivision
3	<u>(1);</u>
4	(3) participate in public awareness and education
5	campaigns;
6	(4) enhance awareness of and encourage participation
7	in the partnership; and
8	(5) share with the secretary of state best practices
9	that are effective in combatting human trafficking.
10	(e) The secretary of state shall work collaboratively with
11	other state agencies to promote the partnership.
12	(f) The secretary of state may use private and philanthropic
13	resources to support the work of the partnership.
14	SECTION 2. Not later than December 1, 2015, the secretary of
15	state shall establish the program designated as the human
16	trafficking prevention business partnership as required under
17	Section 405.023, Government Code, as added by this Act.
18	SECTION 3. This Act takes effect immediately if it receives
19	a vote of two-thirds of all the members elected to each house, as
20	provided by Section 39, Article III, Texas Constitution. If this
21	Act does not receive the vote necessary for immediate effect, this
22	Act takes effect September 1, 2015.
