A BILL TO BE ENTITLED

1 AN ACT

- 2 relating to the transfer of certain state property from the Texas
- 3 Department of Criminal Justice to Fort Bend County.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. (a) In this Act:
- 6 (1) "Utility" means:
- 7 (A) an electric utility, as defined by Section
- 8 31.002, Utilities Code; or
- 9 (B) a gas utility, as defined by Section 101.003
- 10 or 121.001, Utilities Code.
- 11 (2) "Utility infrastructure" means any facility owned
- 12 by a utility.
- 13 (b) Not later than December 31, 2015, the Texas Board of
- 14 Criminal Justice shall donate and transfer to Fort Bend County the
- 15 real property described by Subsection (i) of this section.
- 16 (c) Fort Bend County may use the property transferred under
- 17 this Act only for a public road and utility right-of-way. If Fort
- 18 Bend County uses the property for any purpose other than a public
- 19 road and utility right-of-way, ownership of the property
- 20 automatically reverts to the Texas Department of Criminal Justice.
- 21 (d) The Texas Board of Criminal Justice shall transfer the
- 22 property by an appropriate instrument of transfer. The instrument
- 23 of transfer must:
- 24 (1) provide that:

- 1 (A) Fort Bend County may use the property only
- 2 for a public road and utility right-of-way;
- 3 (B) ownership of the property will automatically
- 4 revert to the Texas Department of Criminal Justice if Fort Bend
- 5 County uses the property for any purpose other than a purpose
- 6 described by Paragraph (A) of this subdivision;
- 7 (C) if a relocation of utility infrastructure
- 8 located within the property is requested, the relocation costs are
- 9 paid by the requesting party; and
- 10 (D) the property is subject to an easement
- 11 created for all existing utility infrastructure located within the
- 12 property; and
- 13 (2) describe the property to be transferred by metes
- 14 and bounds.
- 15 (e) The Texas Department of Criminal Justice shall retain
- 16 custody of the instrument of transfer after the instrument of
- 17 transfer is filed in the real property records of Fort Bend County.
- 18 (f) Fort Bend County shall identify and convert Texas
- 19 Department of Criminal Justice utilities located along and within
- 20 the existing roadway to public utilities of the county as necessary
- 21 without disruption in service or cost to the Texas Department of
- 22 Criminal Justice.
- 23 (g) Fort Bend County shall identify and preserve all
- 24 existing access locations to Texas Department of Criminal Justice
- 25 properties and facilities.
- 26 (h) Fort Bend County shall grant all easements, without
- 27 reservation, to the Texas Department of Criminal Justice as

- 1 necessary to maintain utility infrastructure retained by the Texas
- 2 Department of Criminal Justice.
- 3 (i) The real property referred to in this section consists
- 4 of the following two tracts of land:
- 5 (1) Being 10.58 acres (460,792 square feet) of land,
- 6 out of the Remainder of a called 5656.65 acres, conveyed to the
- 7 State of Texas, by deed recorded under Volume 152, Page 423 Deed
- 8 Records of Fort Bend County, Texas (D.R. F.B.C.T.), said 10.58 acre
- 9 tract lying in the Jane Wilkins Survey, Abstract 96 and being more
- 10 particularly described by metes and bounds as follows;
- 11 COMMENCING at a found 5/8 inch iron rod with cap in the east
- 12 right-of-way of Harlem Road, Public R.O.W. varies, being 70' east
- 13 at a right angle of station point 109+40.00, also being the west
- 14 line of said Remainder;

- 6 East, a distance of 560.74 feet, an arc length of 570.23 feet to a
- 7 point of tangency of the herein described tract;
- 8 THENCE North $86^{\circ}19'16"$ East, a distance of 956.53 feet to a set 5/8
- 9 inch iron rod with cap, marking a point of curvature of the herein
- 10 described tract;
- 11 THENCE along a curve to the right, having a radius of 1650.00 feet,
- 12 an internal angle of 31°15'05", a chord bearing of South 78°05'07"
- 13 East, a distance of 888.85 feet, an arc length of 899.98 feet to a
- 14 point of tangency of the herein described tract;
- 15 THENCE South $61^{\circ}03'29''$ East, a distance of 1158.75 feet to a set 5/8
- 16 inch iron rod with cap in the west line of called Tract IV, 143.287
- 17 acres, Grand Parkway 1358, LP by deed recorded under County Clerk's
- 18 File Number (C.F.) 2014037769 Official Public Records of Fort Bend
- 19 County, Texas (O.P.R. F.B.C.T.), marking the northeast corner of

- 22 described tract;
- 23 THENCE South 68°11'07" East, a distance of 2007.90 feet to a found
- 24 alum disk in said west R.O.W. of F.M. 1464, marking the northeast
- 25 corner of the herein described tract;
- 26 THENCE South $21^{\circ}59'27"$ West, along said west R.O.W., a distance of
- 27 57.11 feet to a found alum disk to an internal corner of the herein

- 1 described tract;
- 2 THENCE South $68^{\circ}01'33"$ East, along said west R.O.W., a distance of
- 3 80.02 feet to a point for corner, marking an external corner of the
- 4 herein described tract;
- 5 THENCE South $00^{\circ}27'54"$ East, along said west R.O.W., a distance of
- 6 18.26 feet to the POINT OF BEGINNING and containing a computed 7.24
- 7 acres (315,413 square feet) of land.
- 8 SECTION 2. This Act takes effect September 1, 2015.
