| 1-20 | SECTION 1. (a) In this Act: |
| 1-21 | (1) "Utility" means: |
| 1-22 | (A) an electric utility, as defined by Section |
| 1-23 | 31.002, Utilities Code; or |
| 1-24 | (B) a gas utility, as defined by Section 101.003 |
| 1-25 | or 121.001, Utilities Code. |
| 1-26 | (2) "Utility infrastructure" means any facility owned |

| 1-28 | (b) Not later than December 31, 2015, the Texas Board of |
