- 8 Texas Department of Insurance shall conduct a study to:
- 9 (1) identify in which industries employers tend to
- 10 elect to not participate in the workers' compensation system;
- 11 (2) determine the reasons the employers involved in
- 12 the industries identified in Subdivision (1) of this subsection
- 13 elect to not participate in the workers' compensation system; and
- 14 (3) determine the extent to which injured employees
- 15 whose employers elect to not participate in the workers'
- 16 compensation system rely on public benefits to:
- 17 (A) receive treatment and rehabilitation for
- 18 their injuries; and
- 19 (B) replace lost income while unable to return to
- 20 work due to their injuries.
- 21 (b) The division may require an employer that elects to not
- 22 participate in the workers' compensation system to submit
- 23 information to the division as necessary to complete the study
- 24 under Subsection (a) of this section.

- 1 (c) The commissioner of workers' compensation shall submit 2 a report containing the findings of the study required under 3 Subsection (a) of this section to the governor, lieutenant 4 governor, speaker of the house of representatives, and appropriate 5 standing committees of the legislature not later than September 1, 6 2016.
- 7 SECTION 2. This Act expires December 31, 2016.
- 8 SECTION 3. This Act takes effect September 1, 2015.
