representatives may refuse to allow persons having no legitimate business to enter on property under the board's control, and may eject any undesirable person from the property on <u>the person's</u> [<u>his</u>] refusal to leave peaceably on request. Identification may be required of any person on the property, and the person must provide <u>that identification on request</u>.

SECTION 5. Section 51.202(b), Education Code, is repealed.
SECTION 6. This Act takes effect September 1, 2015.
