5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Chapter 344, Local Government Code, is amended
7	by adding Subchapter D-1 to read as follows:
8	SUBCHAPTER D-1. ADDITION OF TERRITORY TO DISTRICT
9	Sec. 344.181. ELECTION REQUIRED. The municipality that
10	created a district may add all or part of the territory in the
11	municipality's extraterritorial jurisdiction to the district and
12	the district may impose a tax in that territory only if the addition
13	of the territory and the imposition of the tax are approved by a
14	majority of the qualified voters of the territory to be added voting
15	at an election held for that purpose.
16	Sec. 344.182. CONFIRMATION ELECTION ORDER. (a) The board
17	may not call and hold a confirmation election until the board adopts
18	a budget plan and a fire control, prevention, and emergency medical
19	services plan under Section 344.061 that include the proposed
20	addition of territory.
21	(b) An order calling an election under Subsection (a) must
22	state:
23	(1) the nature of the election, including the
24	proposition that is to appear on the ballot;

1	(2) the date of the election;
2	(3) the hours during which the polls will be open;
3	(4) the location of the polling places;
4	(5) a summary of the district's budget plan and fire
5	control, prevention, and emergency medical services plan that
6	includes the proposed addition of territory; and
7	(6) the proposed rate of the sales and use tax to be
8	imposed in the territory to be added.
9	Sec. 344.183. NOTICE OF ELECTION. In addition to the notice
10	required by Section 4.003(c), Election Code, the board shall give
11	notice of an election to add territory to the district by publishing
12	a substantial copy of the election order in a newspaper with general
13	circulation in the territory to be added once a week for two
14	consecutive weeks. The first publication must appear before the
15	35th day before the date set for the election.
16	Sec. 344.184. BALLOT PROPOSITION. The ballot for an
17	election to add territory to a district shall be printed to permit
18	voting for or against the proposition: "The addition of
19	(description of territory to be added) to the (name of the
20	municipality that created the district) Fire Control, Prevention,
21	and Emergency Medical Services District dedicated to fire safety
22	and emergency medical services programs and the adoption of a
23	proposed local sales and use tax in the territory to be added at a
24	<pre>rate of (rate specified in the election order)."</pre>
25	Sec. 344.185. ELECTION RESULTS. (a) If a majority of the
26	votes cast in the election favor the addition of the territory to
27	the district, the board shall issue an order declaring the

territory added to the boundaries of the district. 1 2 (b) If a majority of the votes cast in the election do not favor the addition of the territory to the district, the board may 3 not order another election on the matter before the first 4 5 anniversary of the date of the most recent election. 6 (c) The provisions of Section 321.102, Tax Code, governing 7 the application of a municipal sales and use tax in the event of a 8 change in the boundaries of a municipality apply to the application of a tax imposed under this chapter to territory added under this 9 10 subchapter. SECTION 2. Chapter 363, Local Government Code, is amended 11 12 by adding Subchapter D-1 to read as follows: SUBCHAPTER D-1. AD<u>DITION OF TERRITORY TO DISTRICT</u> 13 Sec. 363.181. ELECTION REQUIRED. The governing body that 14 15 created a district may add all or part of the territory in the political subdivision governed by that body to the district and the 16 17 district may impose a tax in that territory only if the addition of the territory and the imposition of the tax are approved by a 18 19 majority of the qualified voters of the territory to be added voting at an election held for that purpose. 20 21 Sec. 363.182. ELECTION ORDER. (a) After a majority of the 22 board has approved a budget plan and a crime control plan in accordance with Section 363.061 that include the proposed addition 23 24 of territory, a majority of the board may order that an additional election be held. 25 26 (b) An order calling an election under Subsection (a) must 27 state:

24	adoption of a proposed local sales and use tax in the territory to
25	be added at a rate of (rate specified in the election

27	Sec. 363.185. ELECTION RESULTS. (a) If a majority of the

1 votes cast in the election favor the addition of the territory to the district, the board shall issue an order declaring the 2 territory added to the boundaries of the district. 3 4 (b) If a majority of the votes cast in the election do not favor the addition of territory to the district, the board may not 5 6 order another election on the matter before the first anniversary 7 of the date of the most recent election. (c) The provisions of Section 321.102, Tax Code, governing 8 the application of a municipal sales and use tax in the event of a 9 change in the boundaries of a municipality apply to the application 10 of a tax imposed under this chapter to territory added under this 11

13 SECTION 3. This Act takes effect immediately if it receives 14 a vote of two-thirds of all the members elected to each house, as 15 provided by Section 39, Article III, Texas Constitution. If this 16 Act does not receive the vote necessary for immediate effect, this 17 Act takes effect September 1, 2015.
