1 good or service] by an amount equal to or greater than all or part of 2 the applicable insurance deductible <u>or other uninsured amount owed</u> 3 <u>by an insured under the terms of the applicable policy</u> [paid by the 4 <u>person to an insurer on behalf of an insured or remitted to an</u> 5 <u>insured by the person as a rebate</u>].

6 (b) A person who is insured under a property or casualty7 insurance policy commits an offense if the person:

8 (1) submits<u>, either directly or indirectly</u>, a claim 9 under the policy based on <u>conduct</u> [charges] that <u>is</u> [are] in 10 violation of Subsection (a) [of this section]; or

(2) knowingly allows a claim in violation of Subsection (a) [of this section] to be submitted, unless the person promptly notifies the insurer of the <u>conduct in violation of</u> <u>Subsection (a)</u> [excessive charges].

15 SECTION 2. The change in law made by this Act applies only to an offense committed on or after the effective date of this Act. 16 An offense committed before the effective date of this Act is 17 governed by the law in effect on the date the offense was committed, 18 and the former law is continued in effect for that purpose. 19 For purposes of this section, an offense was committed before the 20 effective date of this Act if any element of the offense occurred 21 before that date. 22

SECTION 3. This Act takes effect September 1, 2015.
