3	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
4	SECTION 1. Section 228.302, Insurance Code, is amended by
5	adding Subsection (c-1) to read as follows:
6	(c-1) Notwithstanding any other provision of this section,
7	the comptroller may decertify a certified capital company if the
8	comptroller receives a request in writing from the certified
9	capital company stating that the certified capital company has made
10	qualified investments in an amount cumulatively equal to 100
11	percent of the company's certified capital.
12	SECTION 2. This Act takes effect immediately if it receives
13	a vote of two-thirds of all the members elected to each house, as
14	provided by Section 39, Article III, Texas Constitution. If this
15	Act does not receive the vote necessary for immediate effect, this
16	Act takes effect September 1, 2015.
